

ARTICLES OF ORGANIZATION OF DEFINIDATA, LLC

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the *Code of Alabama* (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is **DEFINIDATA, LLC** (the "Company").

ARTICLE II

Duration


The Company shall have a perpetual duration from the date of organization, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Purposes

The purposes for which the Company is formed are:

- (a) To be involved in the business of publishing data and information. The business shall also include, but not be limited to, graphic art design, creation of illustrations, and investing in related businesses.
- (b) To render to others, and to engage in publishing data and information and engage in all business endeavors allowed under Alabama law as the law pertains to Limited Liability Companies.
- (c) To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (d) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, limited liability

companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

(e) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and

(f) To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Alabama Limited Liability Company Act.

ARTICLE IV

Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be, 11 Lake View Circle, Vandiver, Al 35176 and its registered agent at such address shall be CHRIS BRAKEFIELD.

The Cessation of Membership of one member will not result in the dissolution of the company.


