



The Borrower agrees to be bound by and to perform all of the covenants and agreements in the Line of Credit Agreement, the Modification Agreement, and the Security Instrument.

This Agreement shall not be construed to be a satisfaction, novation or partial release of the Line of Credit Agreement or the Security Instrument.


