

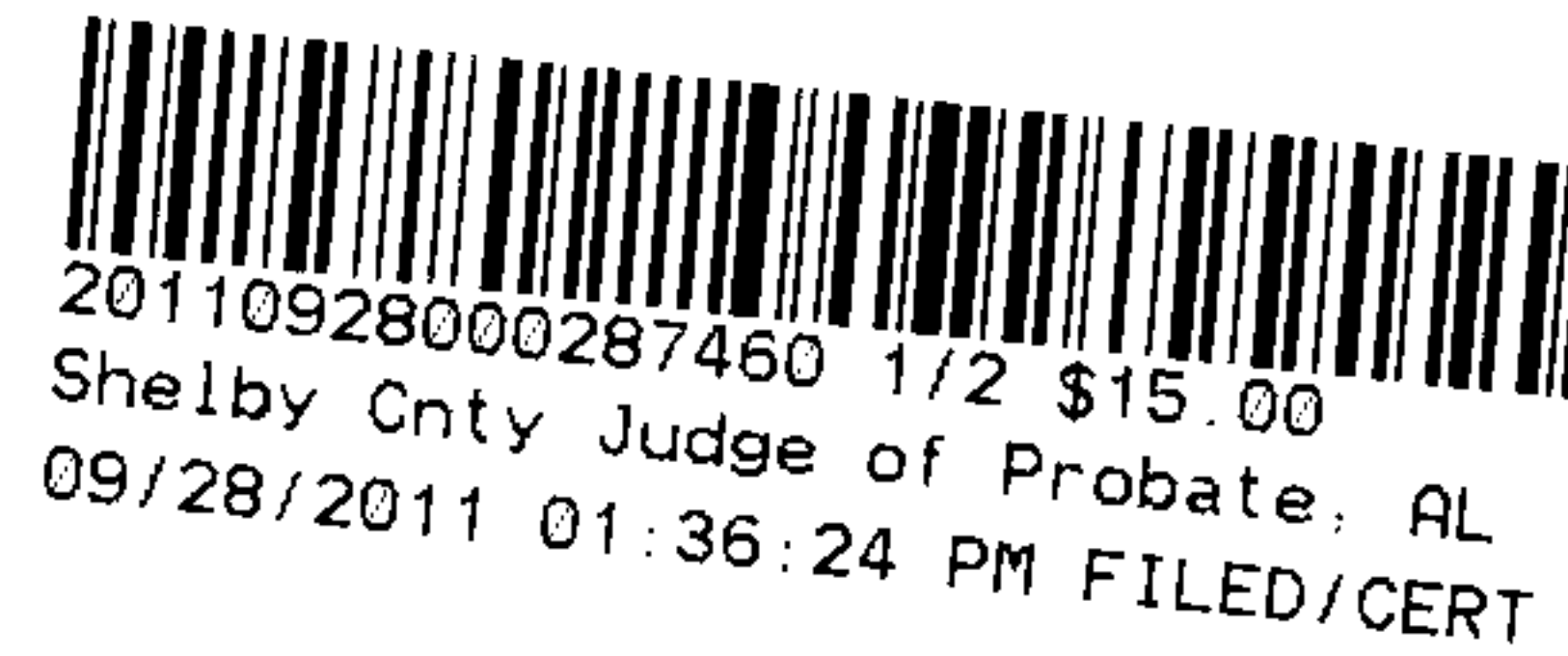

SCRIVENER'S AFFIDAVIT
