(referred to hereinafter as "Grantee")

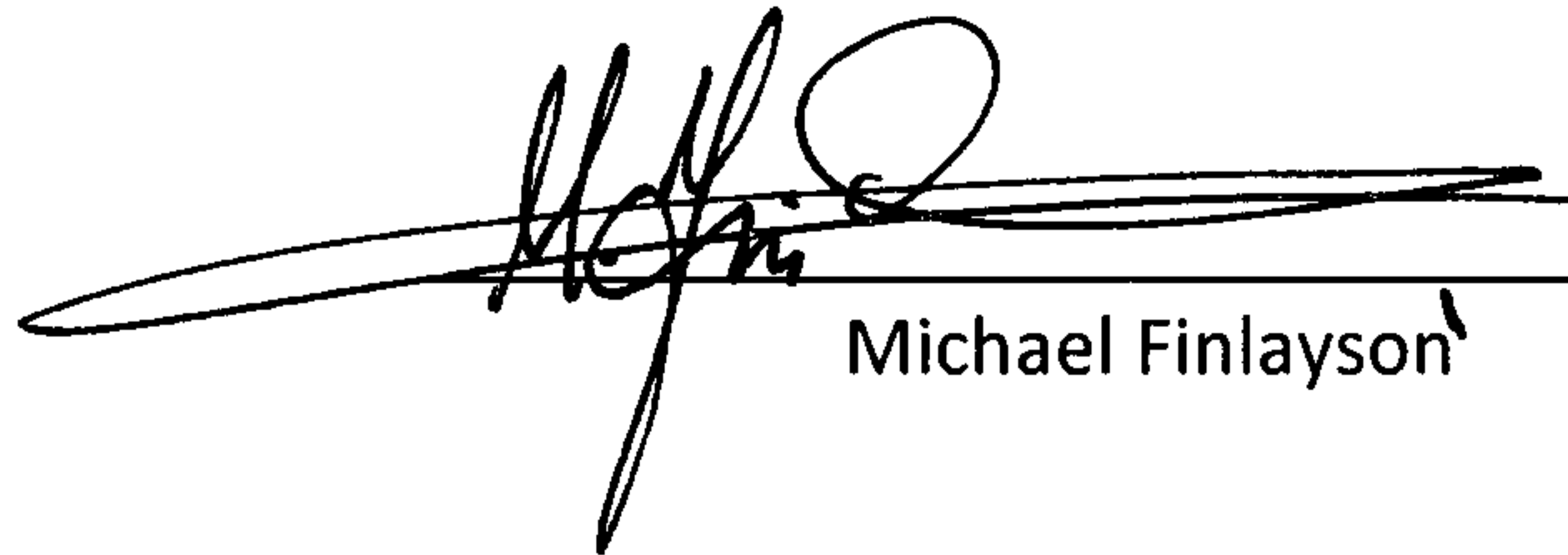
Such real property is more particularly described as:
