

SALE AND ASSIGNMENT OF MEMBERSHIP INTEREST

This Sale and Assignment of Membership Interest is entered into this 15⁴ day of September, 2011, by and between Spencer Harris (Assignor) and Rebekah B. Harris (Assignee).

RECITALS:

- A. On March 30, 2007, Harris Properties Real Estate Holdings 2, LLC, an Alabama limited liability company (the "Company") was formed between Spencer Harris and Brian Harris.
- B. Assignor owns 50 % percent of the membership interest in the Company and has good and marketable title to the same, free and clear for the claims of any creditors.
 - C. Assignor desires to sell and transfer the entire 50 % membership interest to the Assignee.
- D. Assignee desires to purchase Assignor's membership interest and accept such assignment on the terms and conditions contained herein.

NOW, THEREFORE, for TEN (\$10.00) DOLLARS and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and for the mutual promises contained herein, the parties agree among themselves as follows:

- 1. Assignor hereby grants, bargains, sells and assigns to Assignee, Rebekah B. Harris, a 50 % percent membership interest in and to the Company, representing Assignor's entire membership interest.
- 2. Assignee hereby agrees to purchase Assignor's membership interest and to accept such assignment pursuant to terms and conditions contained in the Articles of Organization of the Company.
- 3. Assignor does Warrant, Covenant and Agree that Assignor is the owner of the membership interest of the Company assigned to the Assignee by this Assignment and the membership interest is assigned free and clear of all liens, encumbrances and adverse claims, and Assignor holds legal and beneficial title to said membership interest and has the right to make this Assignment without the consent of any other party. Assignor does further Warrant, Covenant and Agree that Assignor has not caused the Company to be responsible or liable for any matter which Assignor has not specifically disclosed in writing to Assignee.

Brian Harris consents to this Assignment of membership interests to the Assignee solely for the purpose of consenting to the assignment of the interest of Assignor as a Member of the

4. Assignor agrees to indemnify, save and hold Assignee harmless from the claims of any creditors or others claiming an interest in the membership interest transferred hereby.


