


EXHIBIT A

Commence at the Northeast corner of the SE ¼ of the SW ¼ of Section 24, Township 21 South, Range 1 West; thence run West along the North line of the SE ¼ of the SW ¼ a distance of 808.0 feet to the West line of Pine Hill Drive; thence turn an angle of 90 degrees 00 minutes to the left and run along the West line of Pine Hill Drive a distance of 751.50 feet; thence turn an angle of 20 degrees 58 minutes to the left and run along the West line of Pine Hill Drive a distance of 3.99 feet to the point of beginning; thence turn an angle of 110 degrees 58 minutes to the right and run a distance of 264.05 feet; thence turn an angle of 90 degrees 00 minutes to the left and run a distance of 229.0 feet; thence turn an angle of 8 degrees 37 minutes to the left and run a distance of 32.20 feet; thence turn an angle of 102 degrees 16 minutes to the left and run a distance of 336.67 feet to the West line of Pine Hill Drive; thence turn an angle of 90 degrees 05 minutes to the left and run along the West line of Pine Hill Drive a distance of 150.51 feet to the point of beginning; being situated in the SE ¼ of the SW 1/4of Section 24, Township 21 South, Range 1 West, Shelby County, Alabama.
