(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

BOBBIE J. HOWARD AND VIRGINIA H. PETTUS, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE HOWARD LIVING TRUST, DATED SEPTEMBER 26, 2011 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

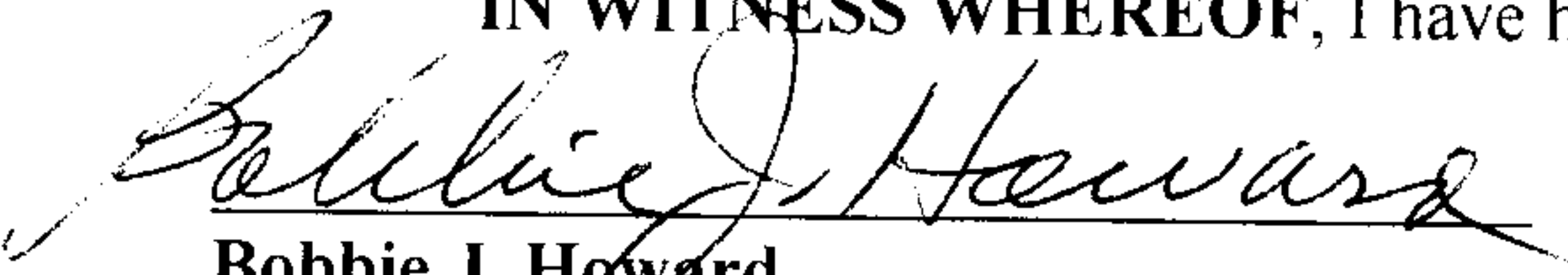
Virginia H. Pettus is a Trustee of the Trust. She does not have any equitable interest in the property.

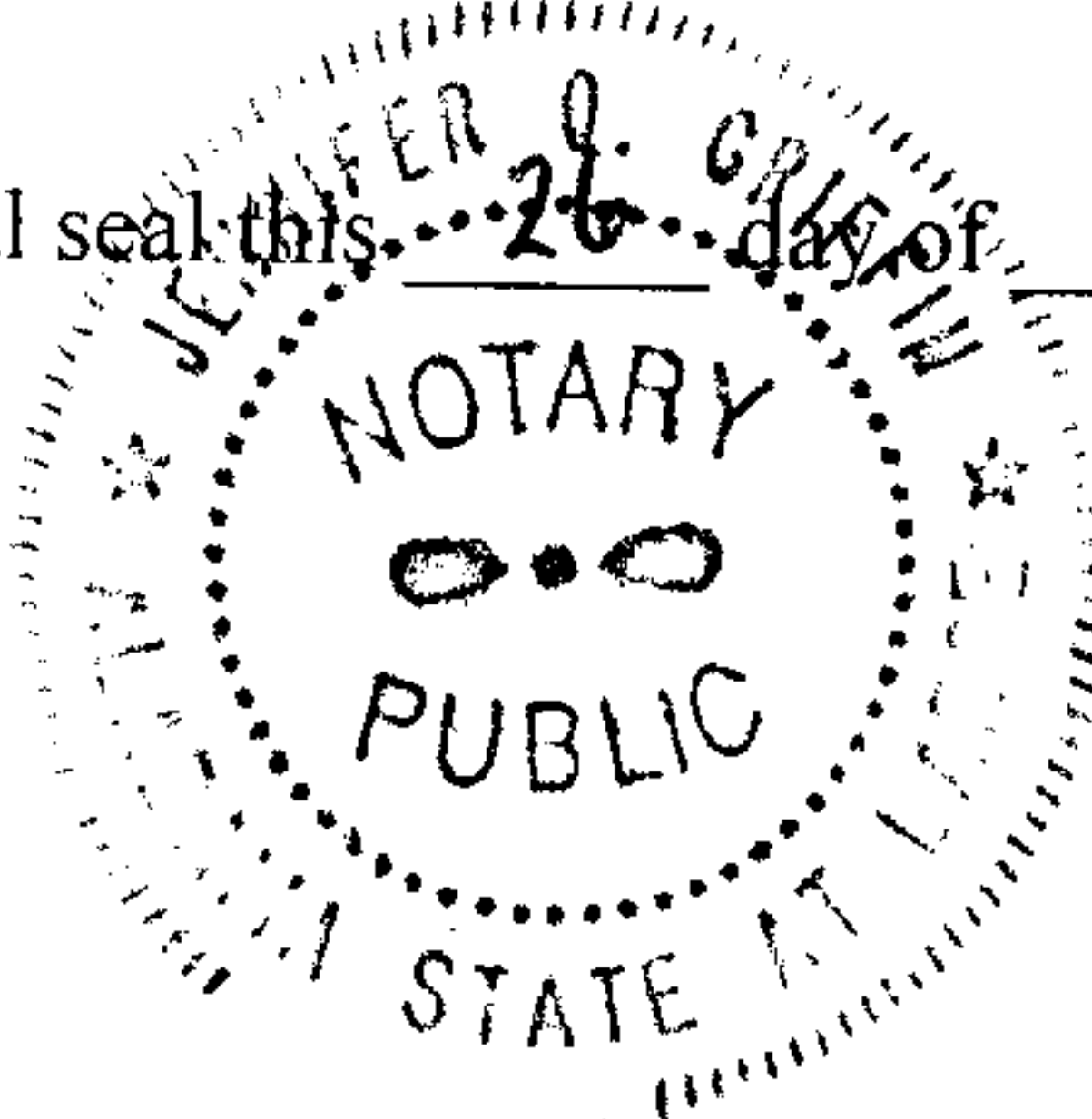
