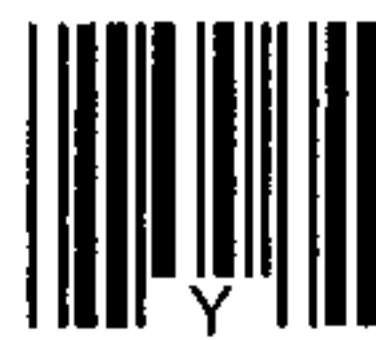
FORECLOSURE DEED

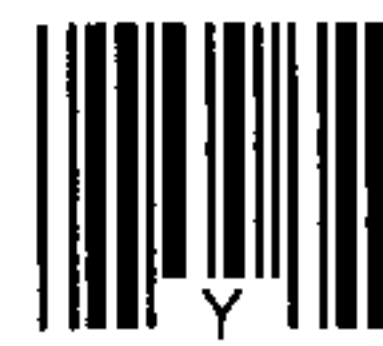
