This company shall exist perpetually until dissolved by the members or any other such and similar act.

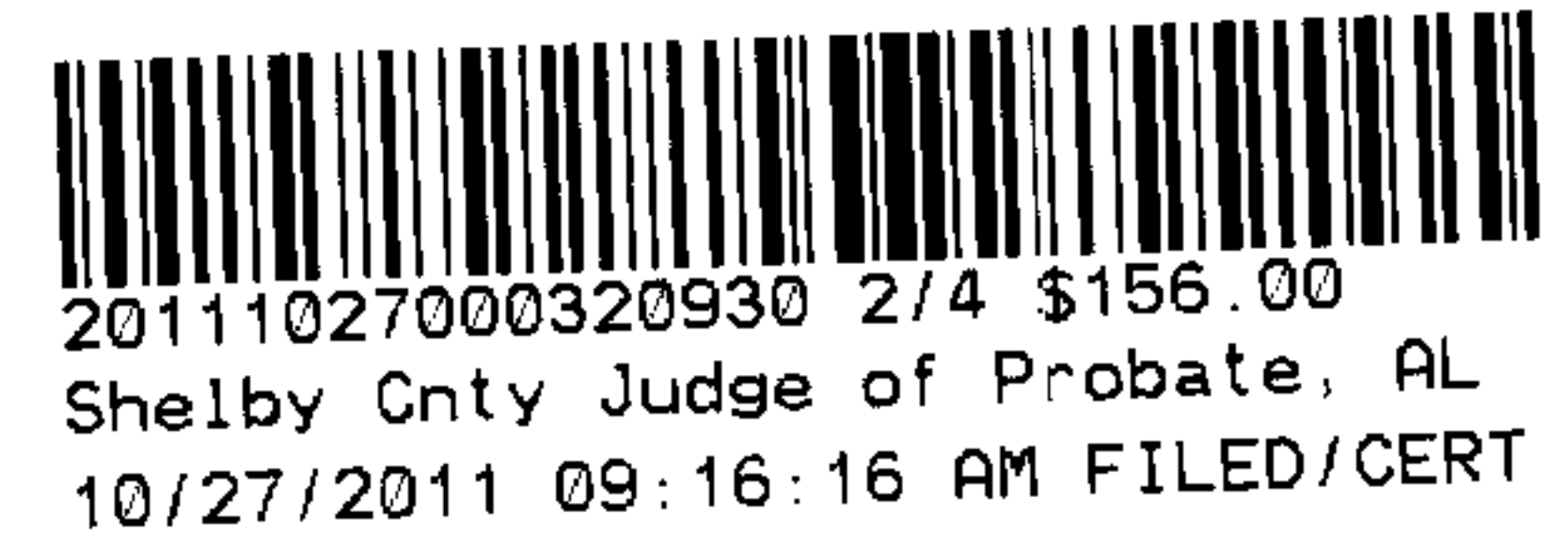
ARTICLE FOUR
