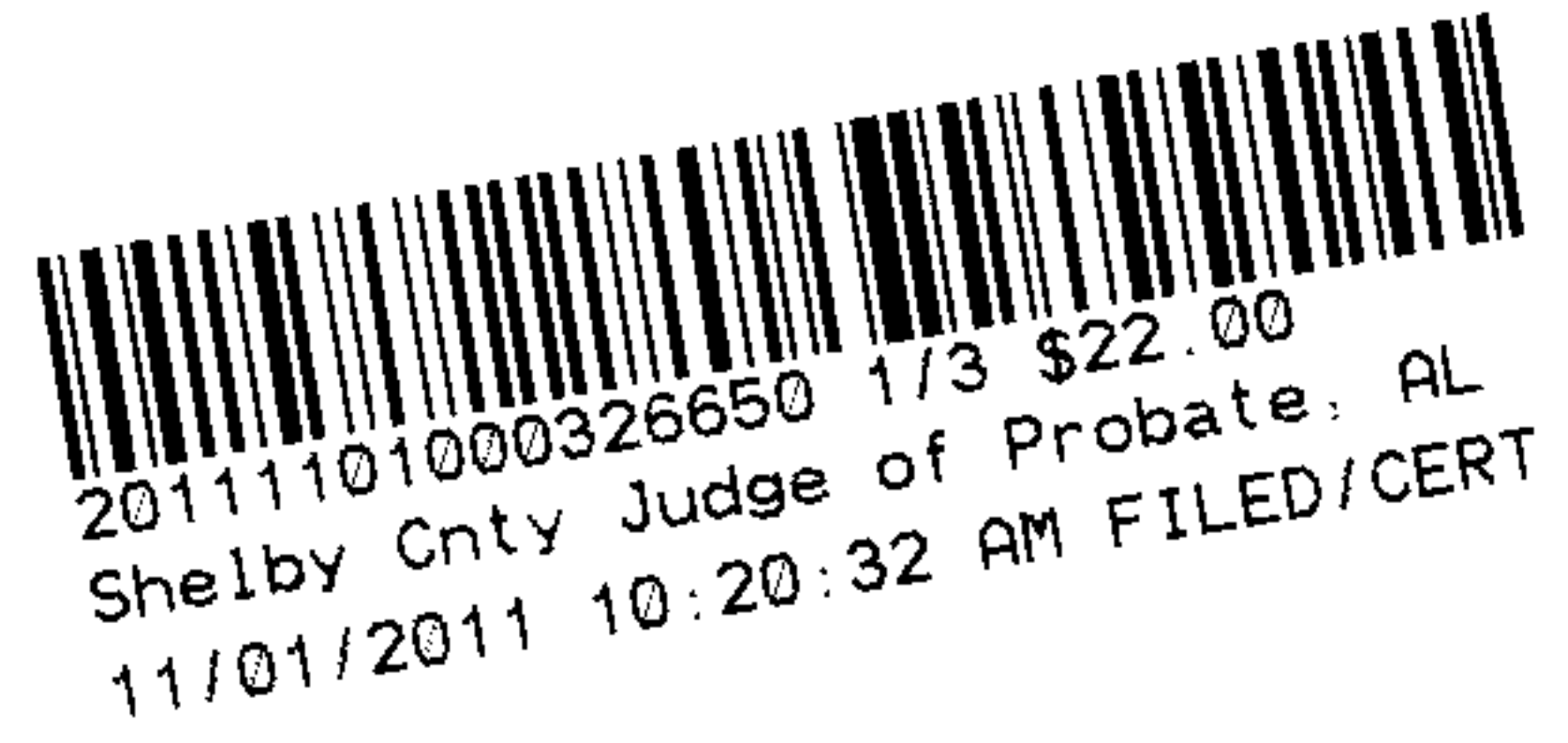

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 14th day of October, 2002, Benjamin C. Moncus, unmarried, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Castle Mortgage Corporation, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20021018000512840, said mortgage having subsequently been transferred and assigned to Countrywide Home Loans Servicing, LP, by instrument recorded in Instrument No: 20090505000165750, in the aforesaid Probate Office ("Transferee"); and

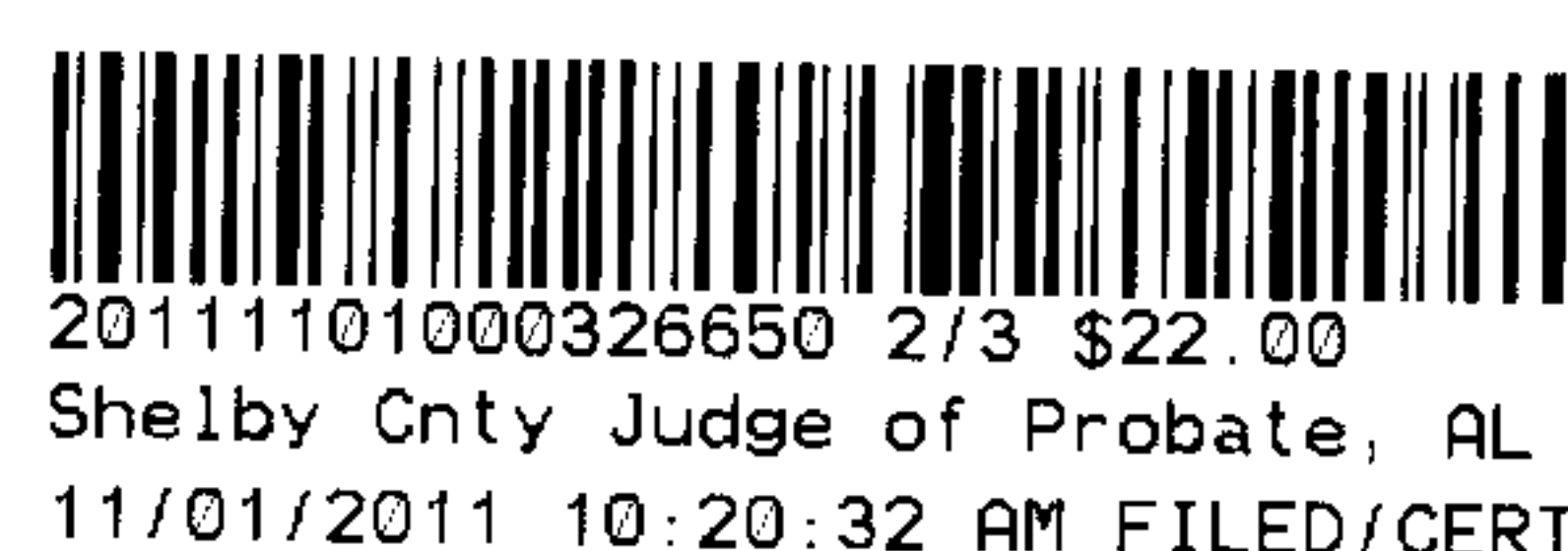
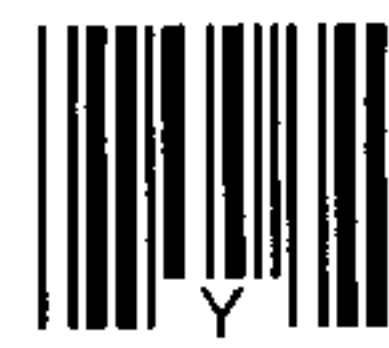

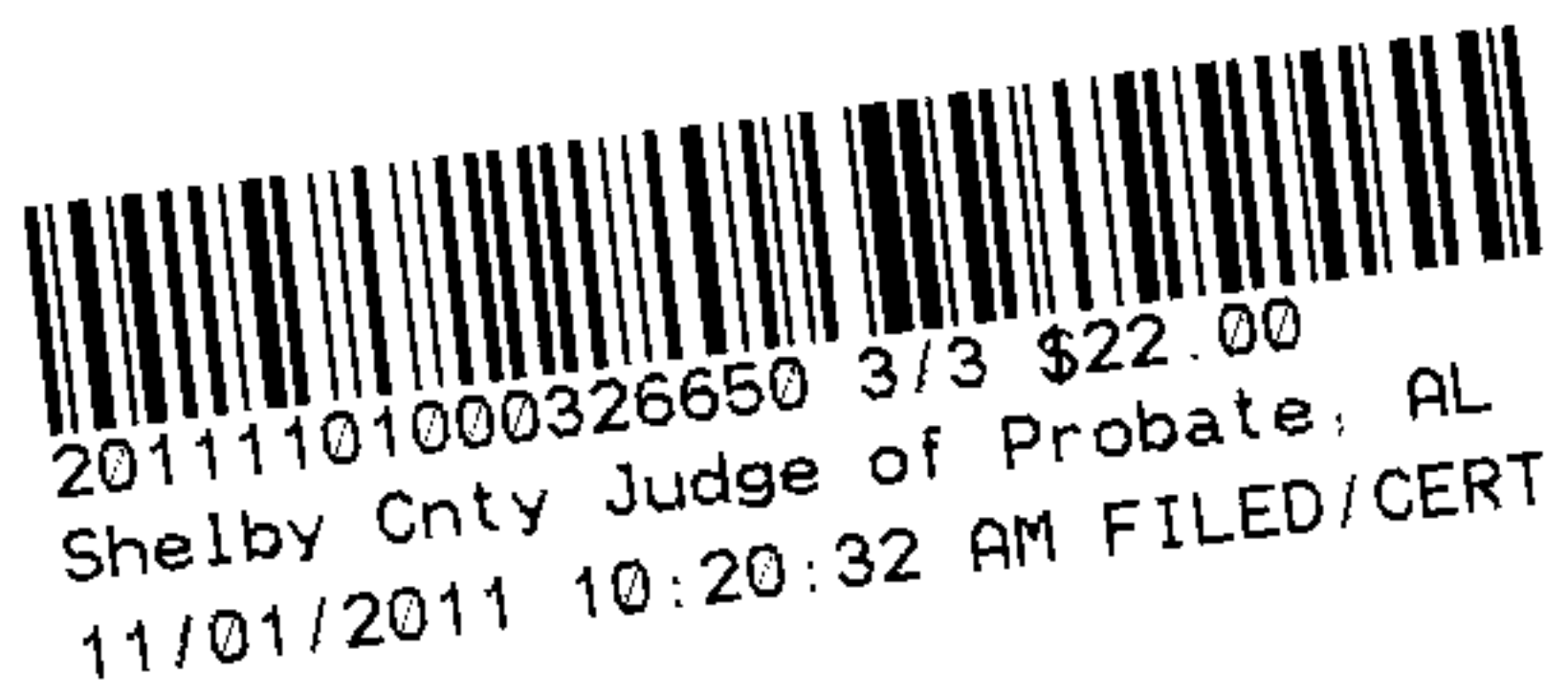
easements, liens, taxes, assessments, rights-of-way, and other matters of record in the aforesaid Probate Office.
