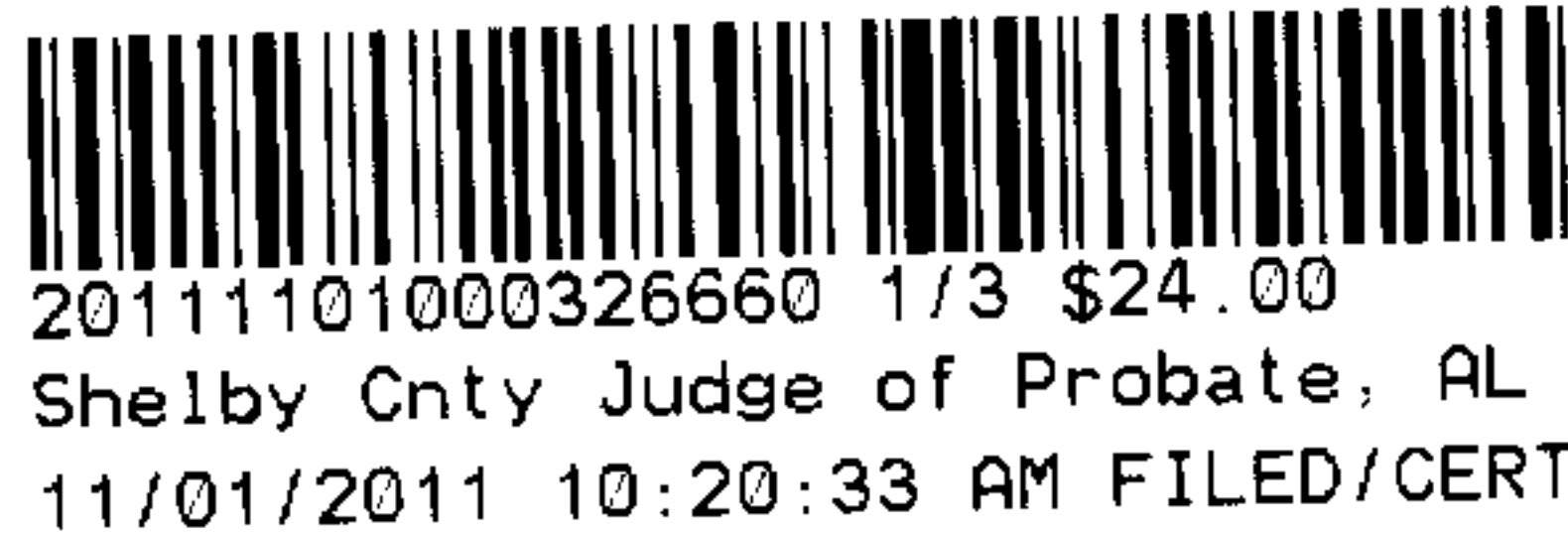

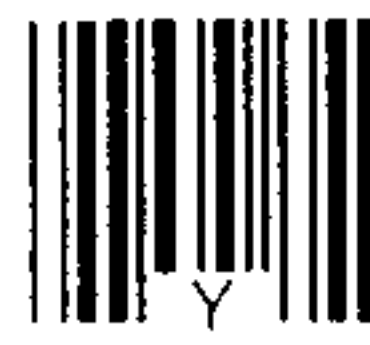
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of July, 2006, Randy Pennington and Tammy Pennington, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Wilmington Finance, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060724000355220, said mortgage having subsequently been transferred and assigned to The Bank of New York Mellon fka The Bank of New York as Trustee for The Benefit of The Certificateholders of The CWABS Inc., Asset-backed Certificates, Series 2006-BC5, by instrument recorded in Instrument No. 20110808000231720, in the aforesaid Probate Office ("Transferee"); and

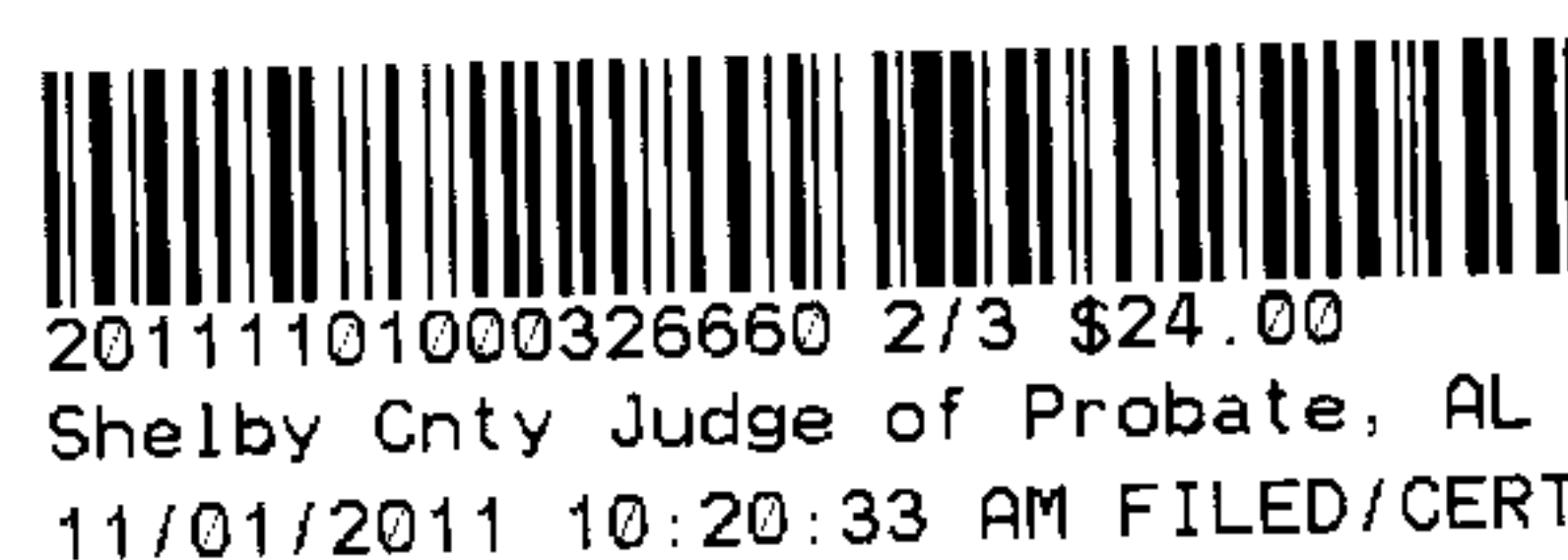
