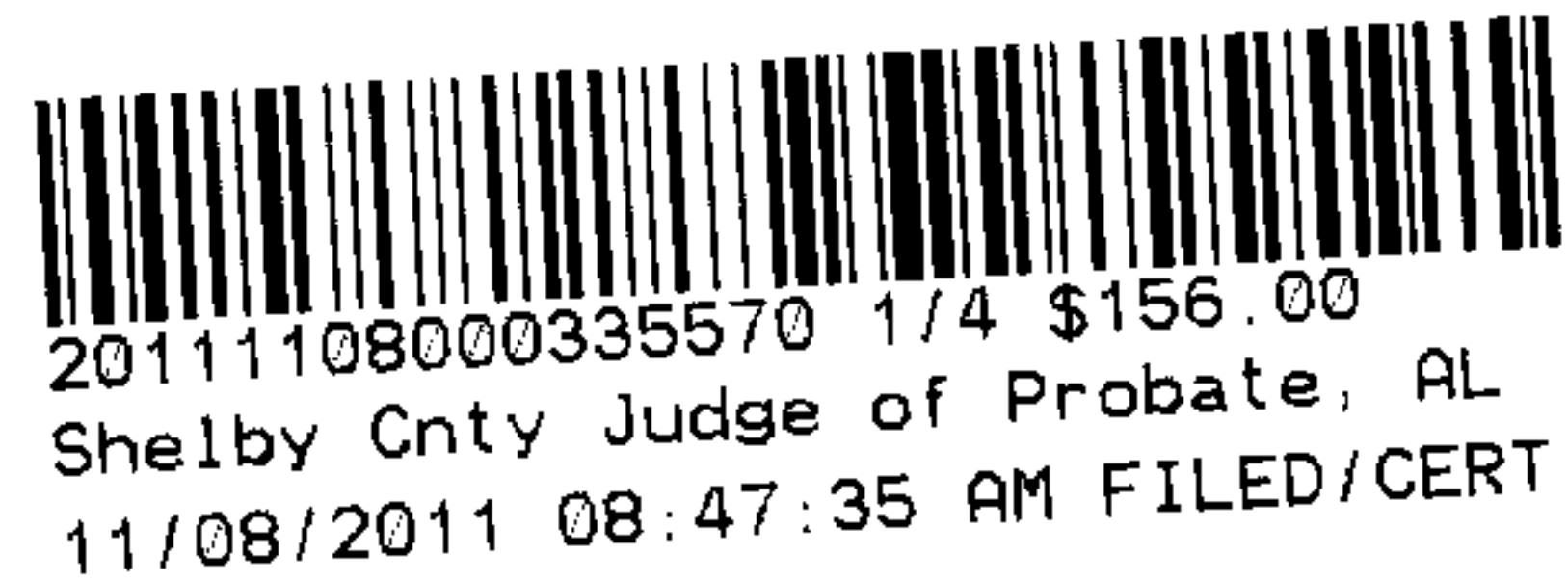

**ARTICLES OF ORGANIZATION
OF
CLAPPING MONKEY, LLC
An Alabama Limited Liability Company**

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

Name

The name of the limited liability company is Clapping Monkey, LLC, an Alabama Limited Liability Company (the "Company").

ARTICLE II

Duration

The Company shall have a duration from the date of organization until December 31, 2051, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III

Purposes

The purpose for which the Company has been organized is to engage in the operation of apparel sales and marketing and to engage in any lawful act or activity for which limited liability companies may be organized pursuant to the Act.

ARTICLE IV

Registered Office; Registered Agent

Cessation of Membership

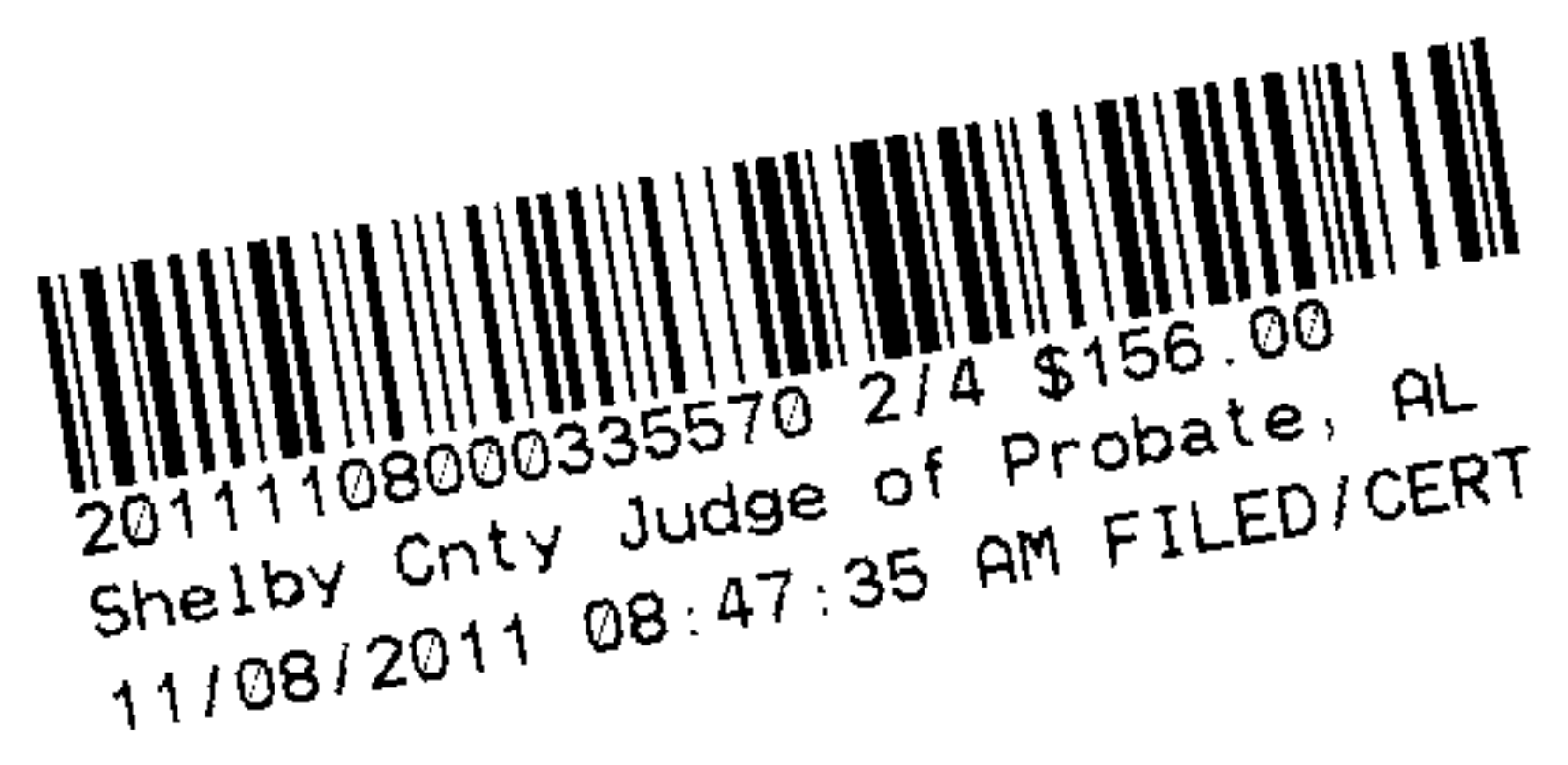
The cessation of membership of one or more members will not result in the dissolution of the Company.

ARTICLE VIII

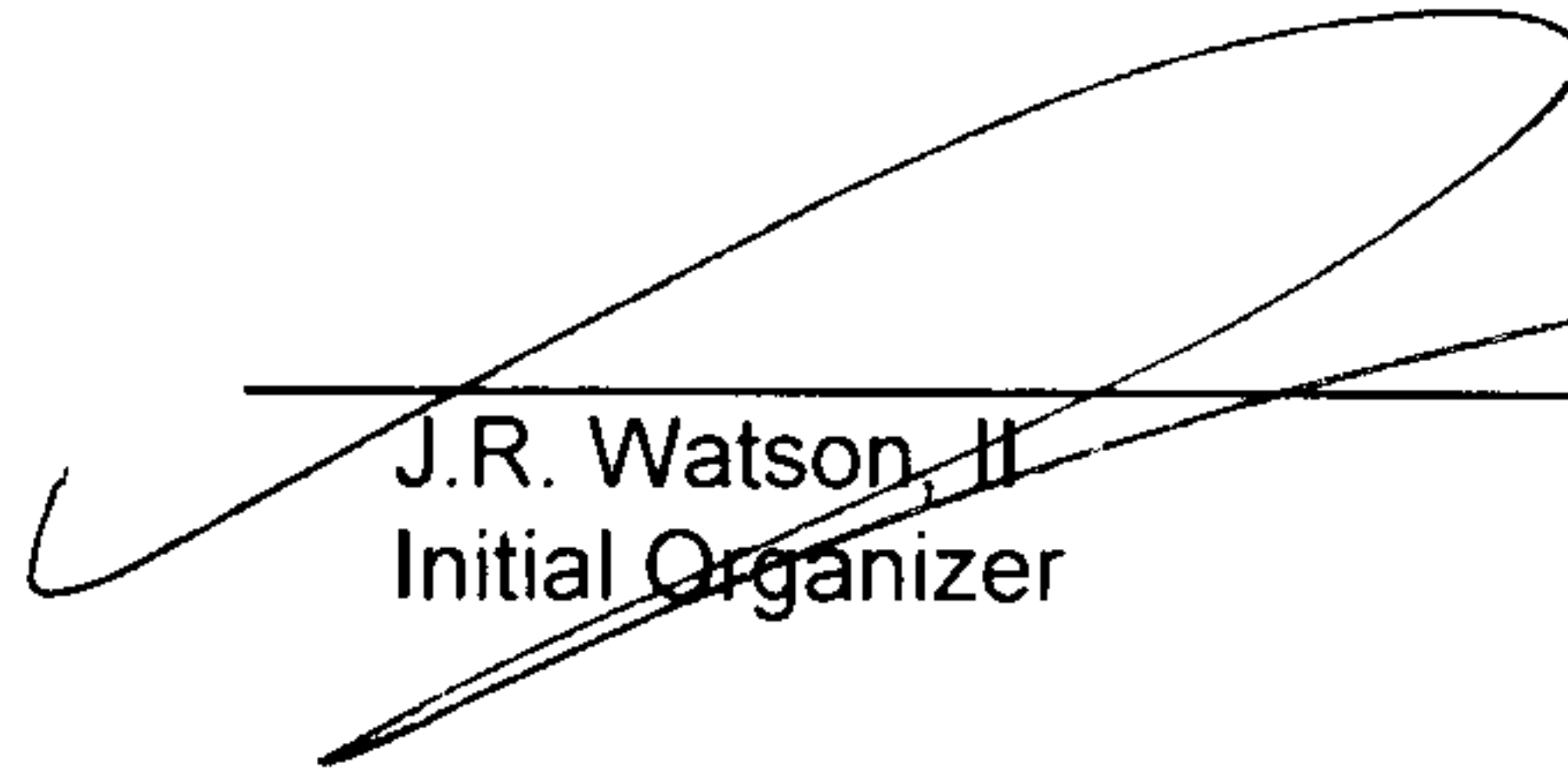
Managers

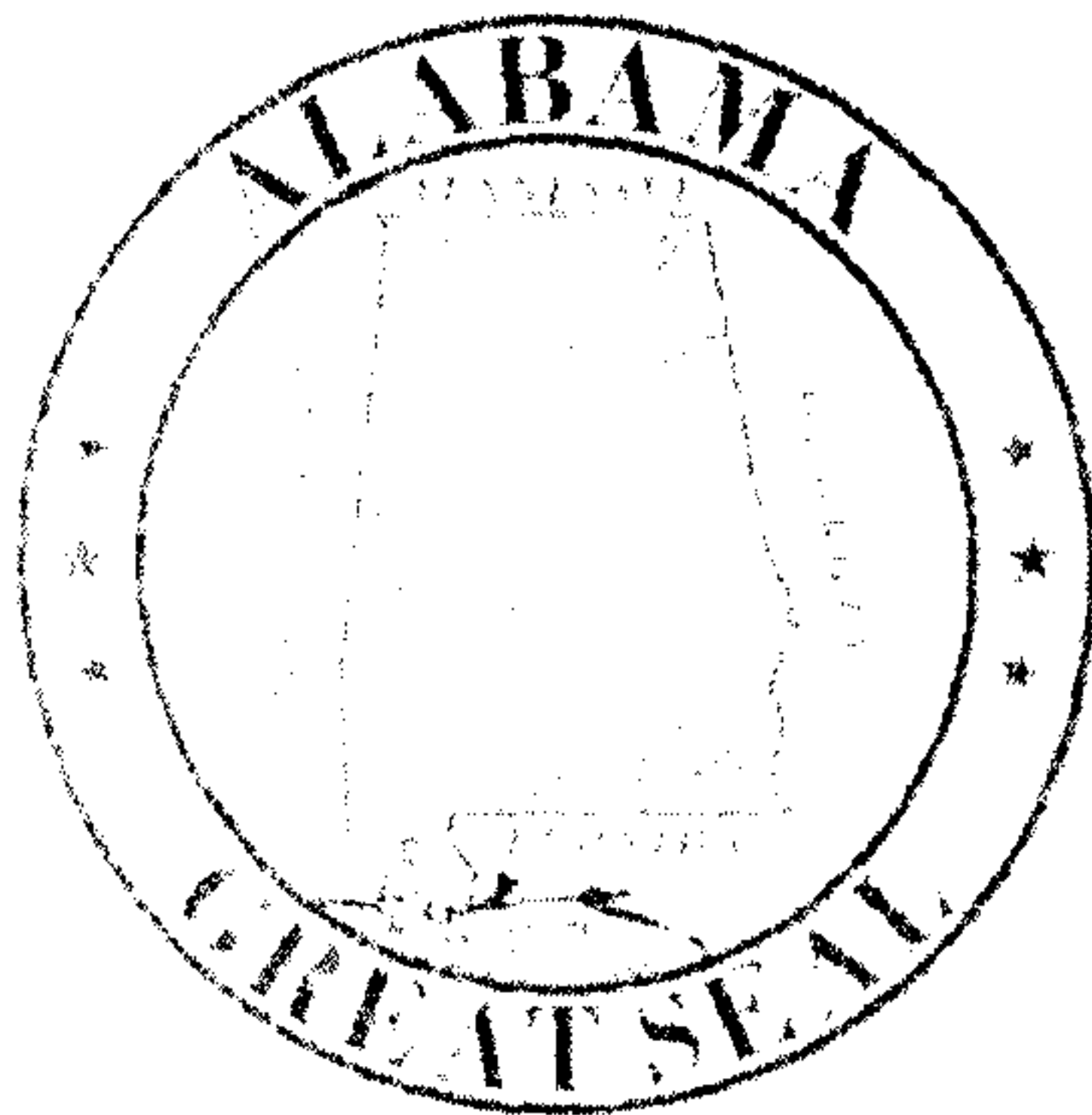
