A part of the NE 1/4 of NE 1/4 of Section 36, Township 19, Range 3 West, described as follows; Begin at the NW corner of the NE 1/4 of NE 1/4 of said Section and run thence along North line of said forty North 88 degrees 30 minutes East 139.1 feet to the beginning point of tract herein described; being on the East right of way line of Highway; thence Southeast along the East Right of way line of said highway South 36 degrees 30 minutes East, 360 feet to North margin of Little Cahaba Road; thence along North margin of said road as follows; North 64 degrees East 244.1 feet; thence 71 degrees East 131 feet; North 63 degrees 30 minutes East 85 feet; North 55 degrees 45 minutes East 214.7 feet to Intersection of North line of said NE 1/4 of NE 1/4 of said Section; thence along North line of said forty South 88 degrees 30 minutes West 810.5 feet to point of beginning .
