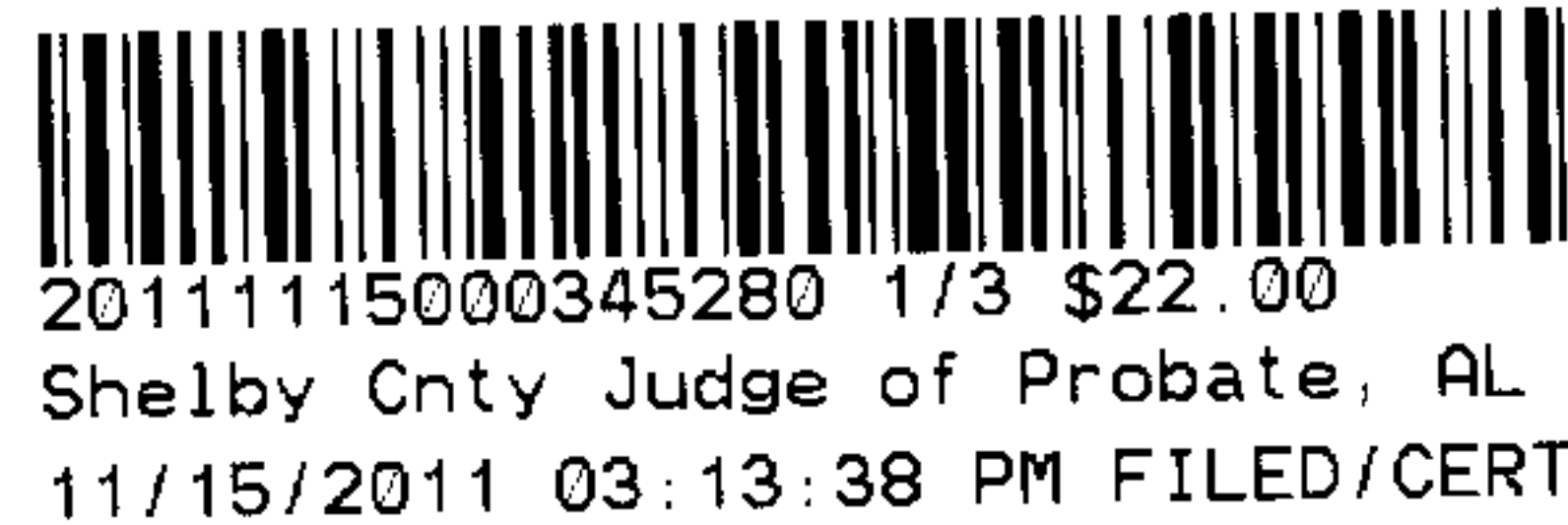

FORECLOSURE DEED

KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore on, to-wit, **07/28/2005**, **GARY C. DANNER**, an unmarried man, as Mortgagors, executed a Real Estate Mortgage on the property hereinafter described to **MERS, MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. ACTING SOLELY AS NOMINEE FOR ACCREDITED HOME LENDERS, INC.** which is recorded as Document No. 200508010003836, in the Office of the Judge of Probate, Shelby County, Alabama on 08/01/2005 and subsequently assigned to OAKMONT POOL 50, LLC and recorded as Document No. 20110621000181290, on 06/21/2011, and,

WHEREAS, on **11/02/2011**, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and the said Mortgagee did offer for sale and sell at public outcry in front of the door of the Courthouse of Shelby County, Alabama, the property hereinafter described; and,

WHEREAS, Melvin Cowan was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,
