### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on, to-wit: the 12<sup>th</sup> day of September, 2008, CODY J. MCKINNEY, a married man and JESSICA MCKINNEY, his wife, executed a mortgage to JPMORGAN CHASE BANK, N.A., herein called the Mortgagee, which said mortgage was recorded on September 25, 2008, in Instrument #20080925000380690, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on the 8<sup>th</sup> day of December, 2010, and the 15<sup>th</sup> day of December, 2010, and the 22<sup>nd</sup> day of December, 2010, that the hereinafter described property would be sold before the front door of the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on the 18<sup>th</sup> day of January, 2011, and

WHEREAS, such sale was postponed by announcements at the courthouse door and by notices published in The Shelby County Reporter; the last postponement having been until the 25<sup>th</sup> day of October, 2011; and


