
Commence at the Southwest corner of Lot 286 according to the survey of Creekside – Phase 2 – Part B as recorded in Map Book 44, Page 26A in the Probate Office of Jefferson County, Alabama, Bessemer Division, said point lying on the Northerly right-of-way of Black Creek Loop North and lying on a curve to the right having a central angle of 31 degrees 12 minutes 22 seconds and a radius of 200.00 feet; thence run in an Northeasterly to Easterly direction along the South line of said Lot 286 and the Southerly line of Lot 285 of said survey and along said right-of-way for 115.91 feet to the Southeast corner of said Lot 285; thence deflect 90 degrees 00 minutes 00 seconds to the right from the tangent of the last described curve and run in a Southerly direction for 50.00 feet; thence deflect 90 degrees 00 minutes 00 seconds to the right to the tangent of a curve to the left having a central angle of 13 degrees 34 minutes 02 seconds and a radius of 150.00 feet and run right to left along the arc of said curve in a Westerly direction for 31.15 feet; thence deflect 77 degrees 27 minutes 12 seconds to right from the tangent of the last described curve to the tangent of a curve to the left having a central angle of 11 degrees 58 minutes 00 seconds and a radius of 40.00 feet and run in a Northerly direction along the arc of said curve for 8.35 feet; thence continue along a tangent curve to the left having a central angle of 86 degrees 47 minutes 44 seconds and a radius of 55.00 feet in a Northerly to Westerly direction for 83.31 feet to the point of beginning.

WHEREAS, the above owner is desirous of vacating said right of way described above and requests that the assent of the Council of the City of Hoover, Alabama, be given as required by law in such cases.




