

**ARTICLES OF ORGANIZATION
OF

Pursuant to the Provisions of the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

ARTICLE I

NAME

BATTERY ROW FARM, LLC

ARTICLE II

DURATION

The term shall be perpetual, unless the Company shall be sooner dissolved and its affairs wound up in accordance with the Alabama Limited Liability Company Act or the Operating Agreement.

ARTICLE III

PURPOSES

The Limited Liability Company has been organized for the following purposes:

To engage in the ownership, operation and management of a real estate project located in Shelby County, Alabama, and to engage in such other lawful activities permitted to limited liability companies by the Alabama Act.

ARTICLE IV

The Member may permit the admission of Additional Members upon such terms and conditions as he may deem appropriate in his sole and absolute discretion.


ARTICLE VIII
