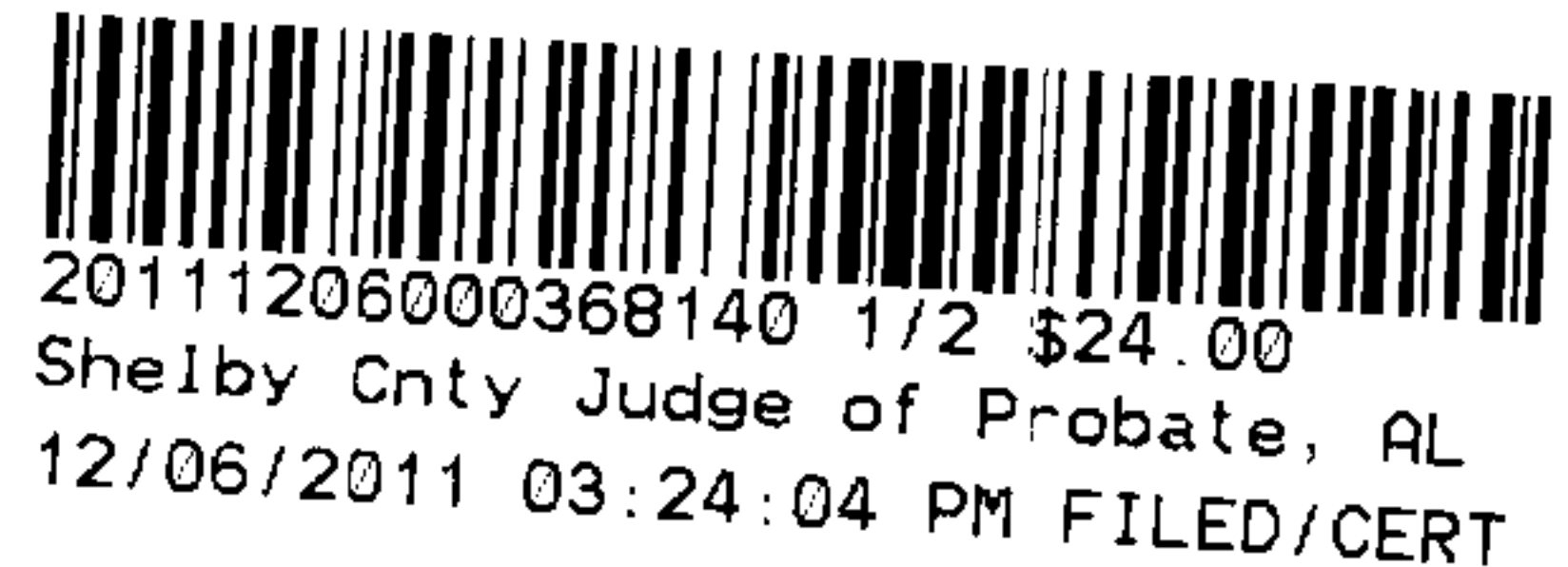


## NOTARY BOND

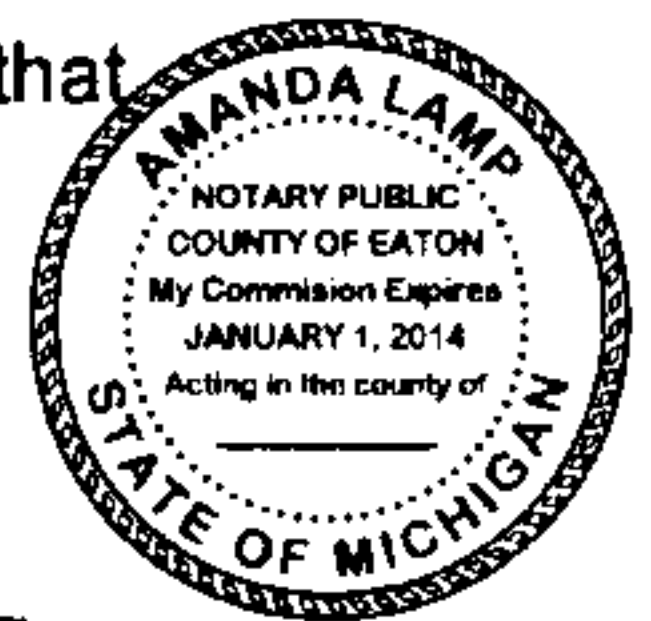
