KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of February, 2004, George Muhia, executed that certain mortgage on real property hereinafter described to National City Mortgage Co dba Commonwealth Mid-Atlantic Mortgage, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20040305000115700, and

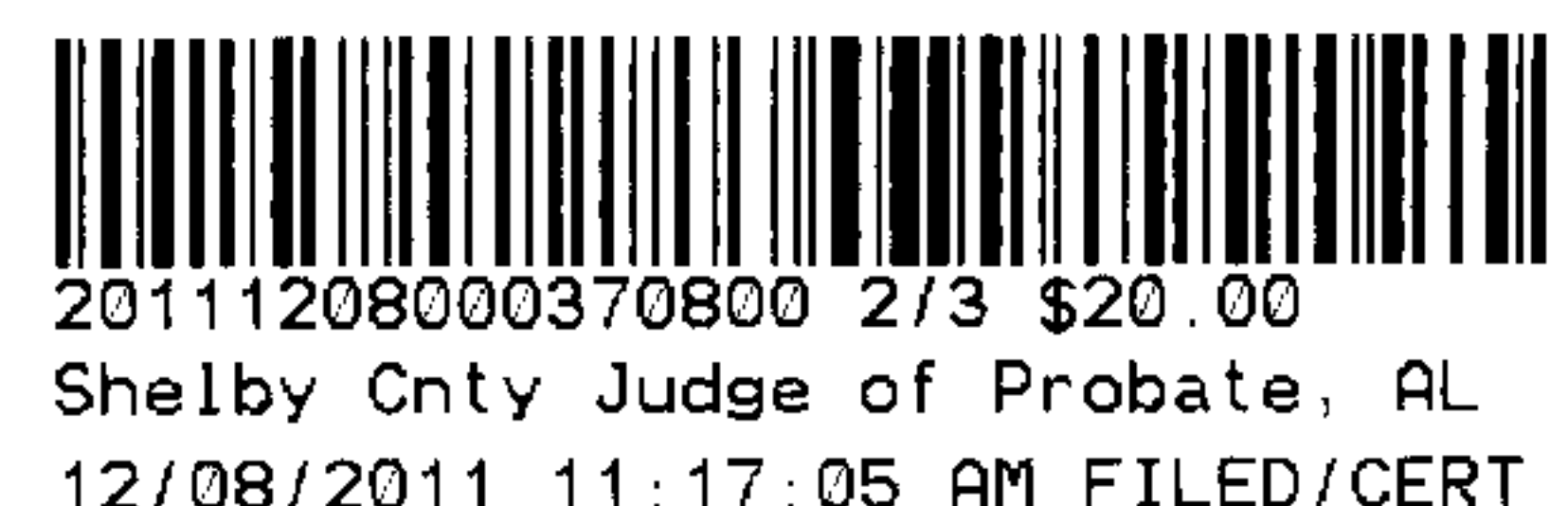


