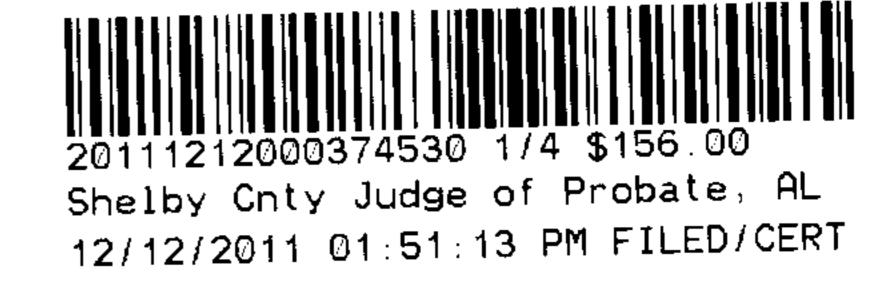
ARTICLES OF ORGANIZATION OF K&J VENTURES, LLC



The undersigned, who intended to form and created a Limited Liability Company, under Title 10A, Chapter 5, of the Code of Alabama (1975), as amended (the "Alabama Limited Liability Company Law"), hereby files the following Articles of Organization with the Probate Judge of Shelby County, Alabama, and affirms that the facts stated in these Articles of Organization are true and correct:

ARTICLE I. NAME OF LIMITED LIABILITY COMPANY

The registered office of the Company is located in the City of Alabaster, State of Alabama. Its registered agent for service of process at the foregoing address shall be:

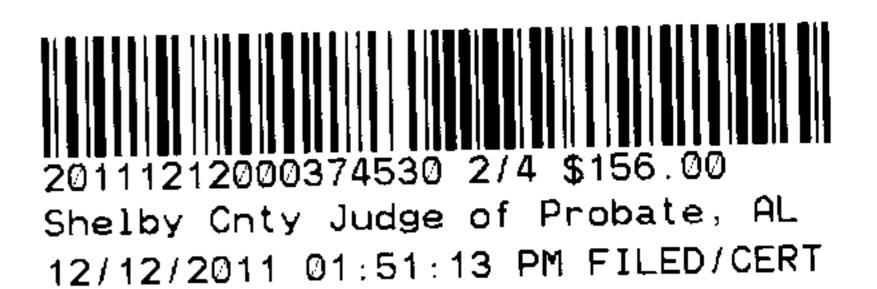

ARTICLE VIII. MANAGEMENT

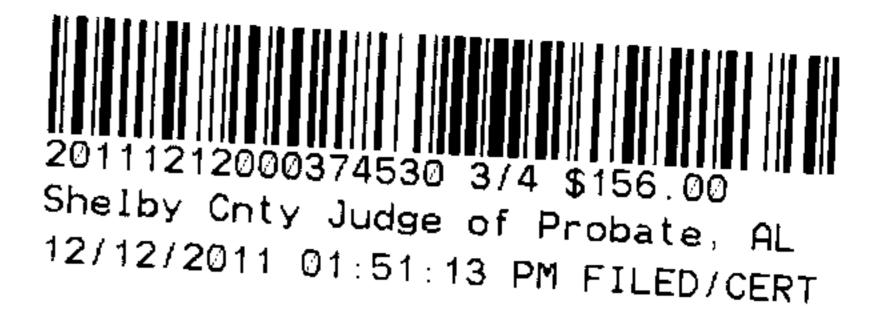

ARTICLE XI. OPERATING AGREEMENT

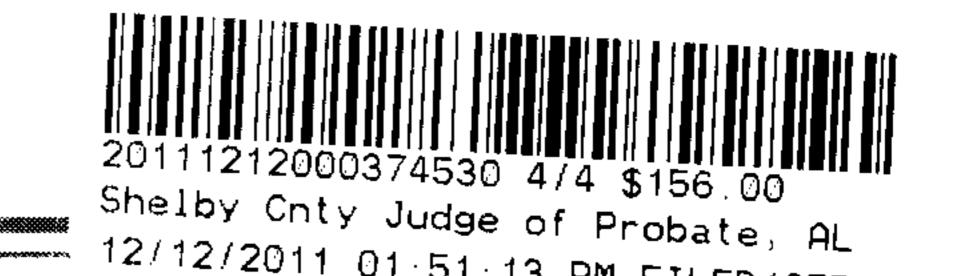
