

**ARTICLES OF ORGANIZATION OF

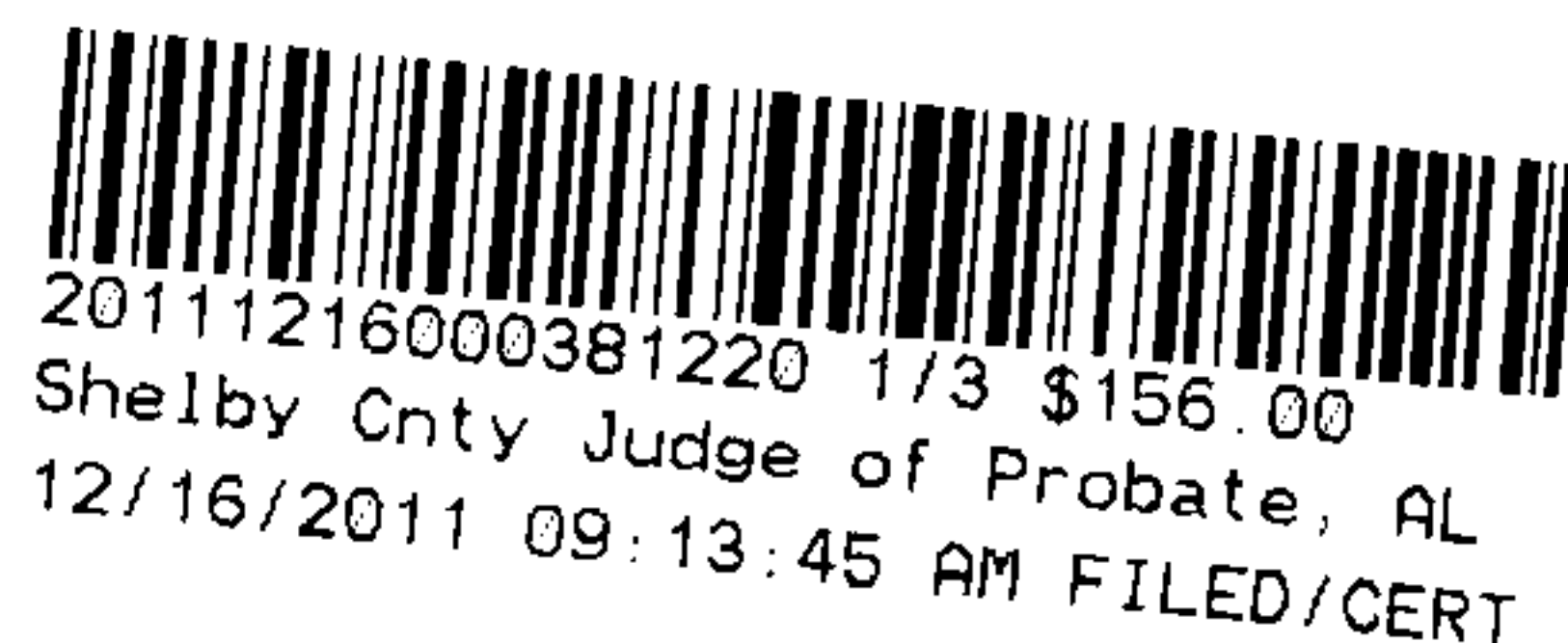

The professional limited liability company will NOT have managers. The company will be governed by its members, the name and address of each initial member are set forth below:

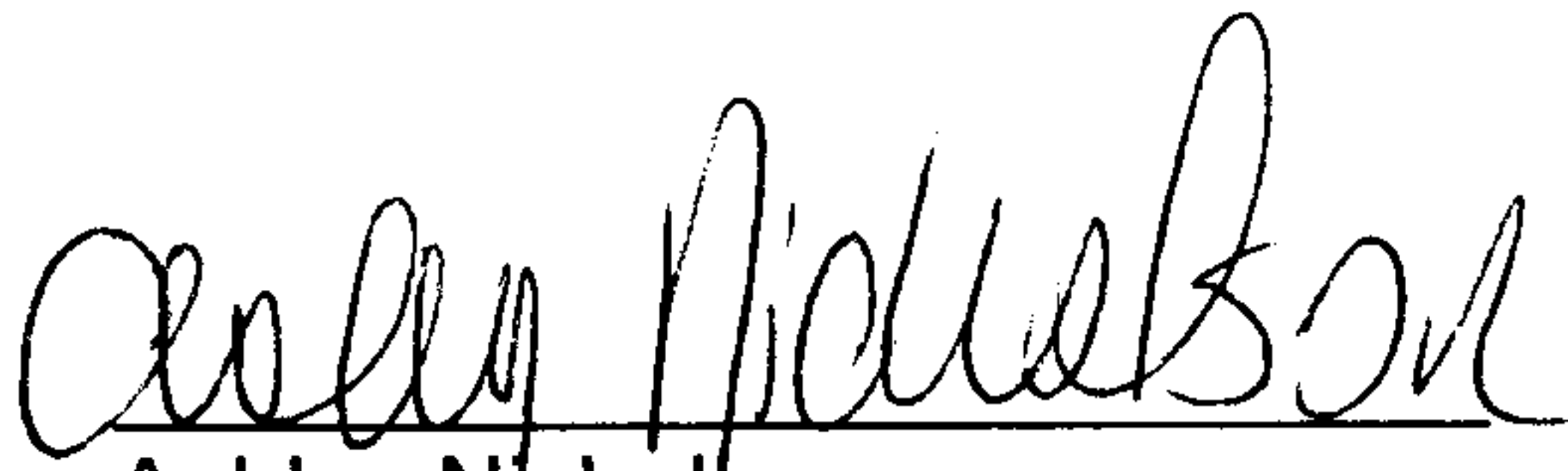

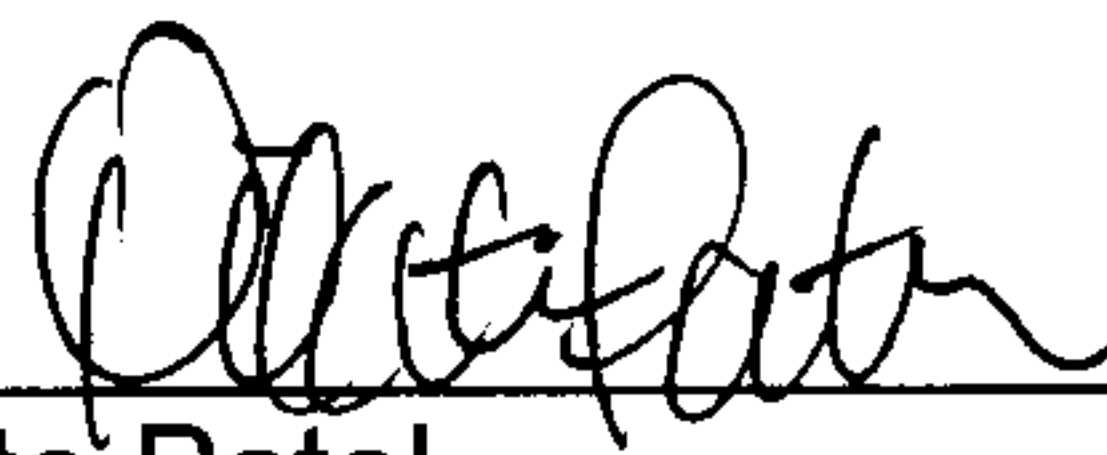
