FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on, to-wit: the 8th day of June, 2007, GARY D. CROWE and wife, JANE R. CROWE, executed a mortgage to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., Solely as nominee for WALTON MORTGAGE, INC., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on 8th day of June, 2007, in Document No. 20070608000270430, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, by assignment dated 4th day of October, 2011, and recorded in Document No. 20111108000336280, Probate Records of Shelby County, Alabama; and
