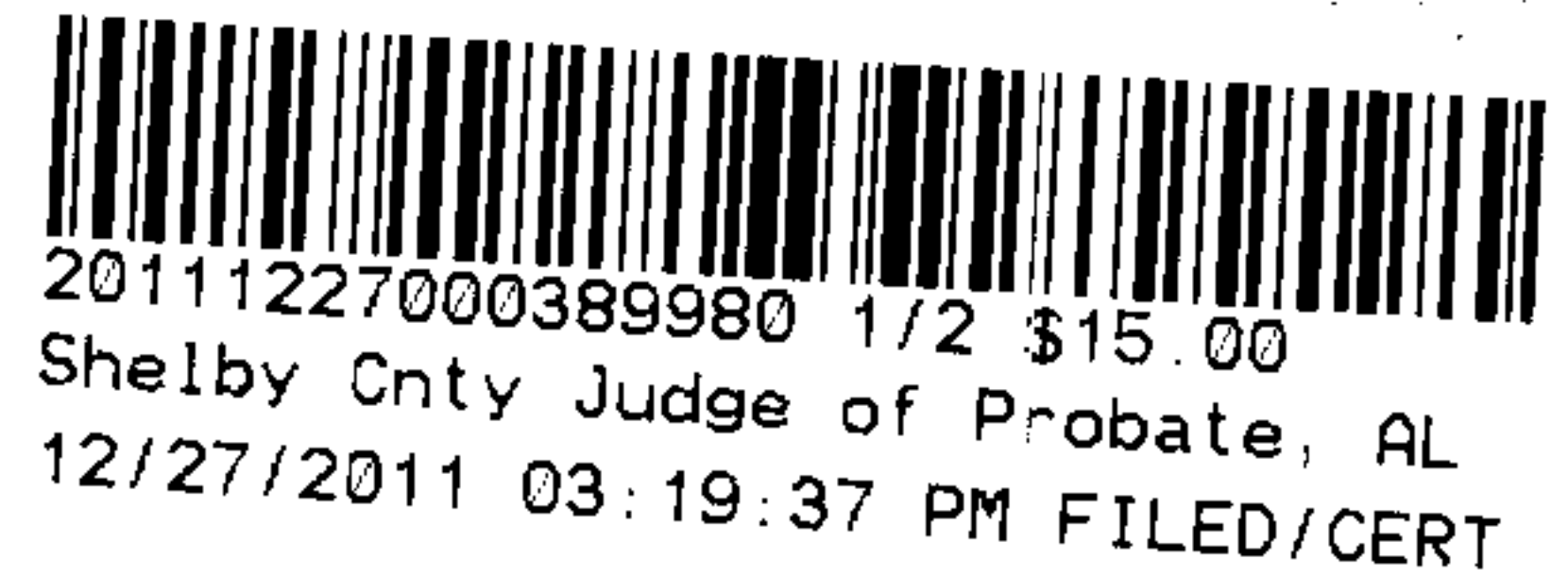

**PARTIAL RELEASE**
