SUBORDINATION OF MORTGAGE

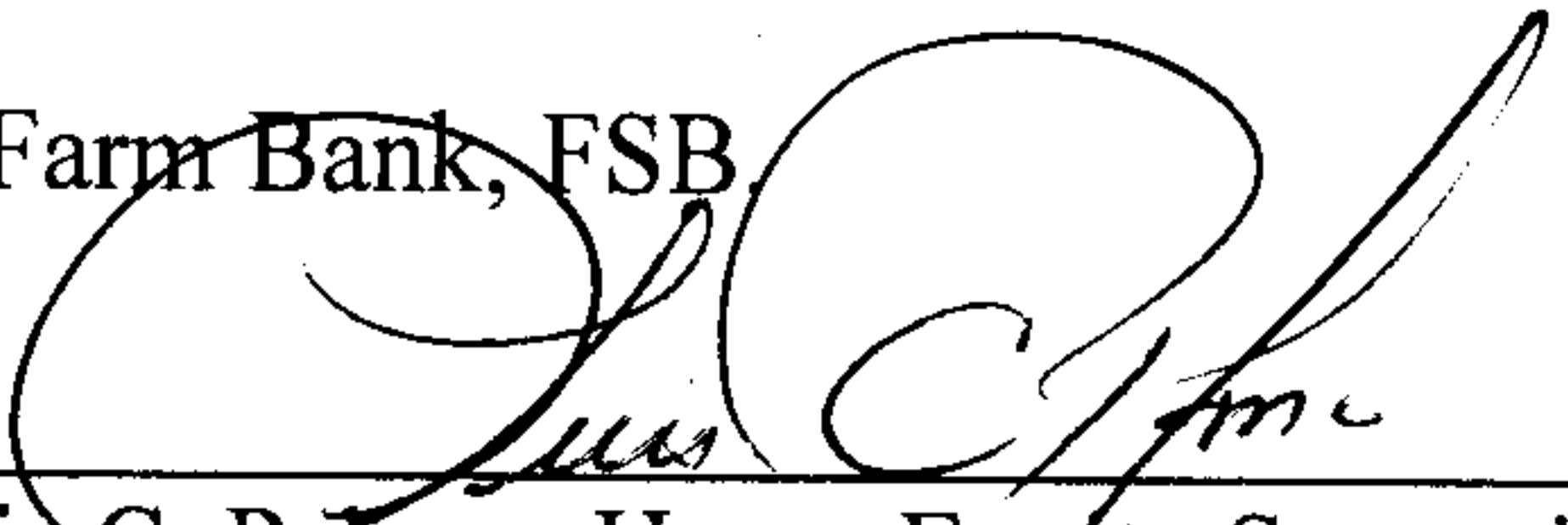

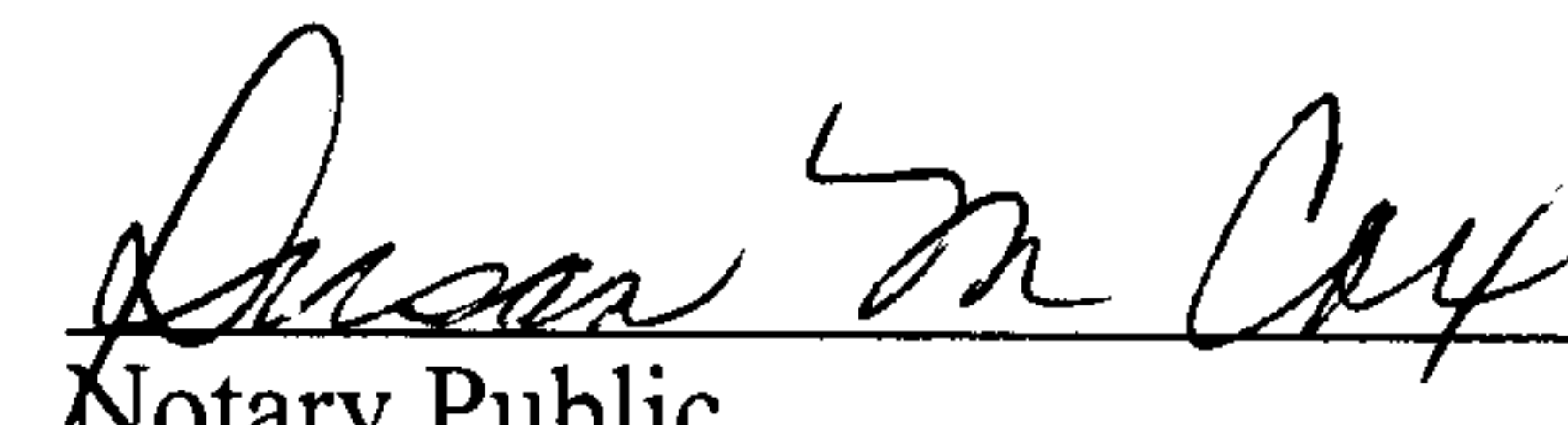

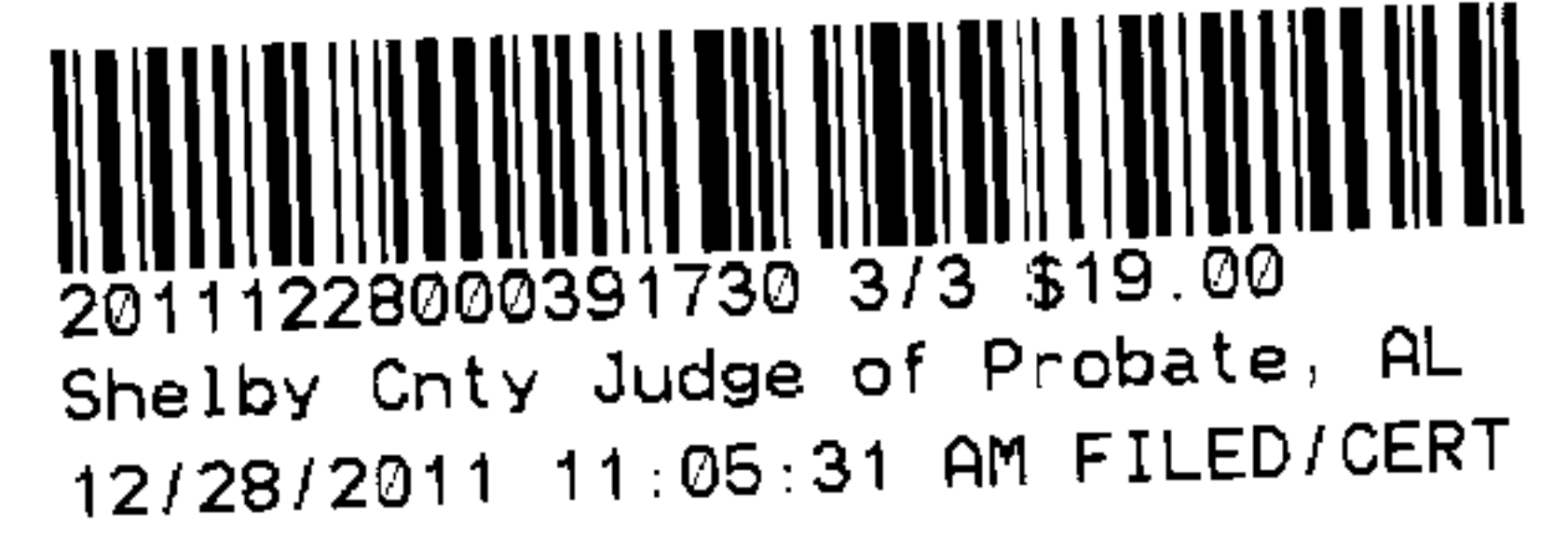
