FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of August, 2006, Hae B Kim, as single woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for NetBank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20060901000431680, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA as trustee for the LMT 2006-9 Trust Fund, by instrument recorded in Instrument No. 20110107000008340, in the aforesaid Probate Office ("Transferee"); and

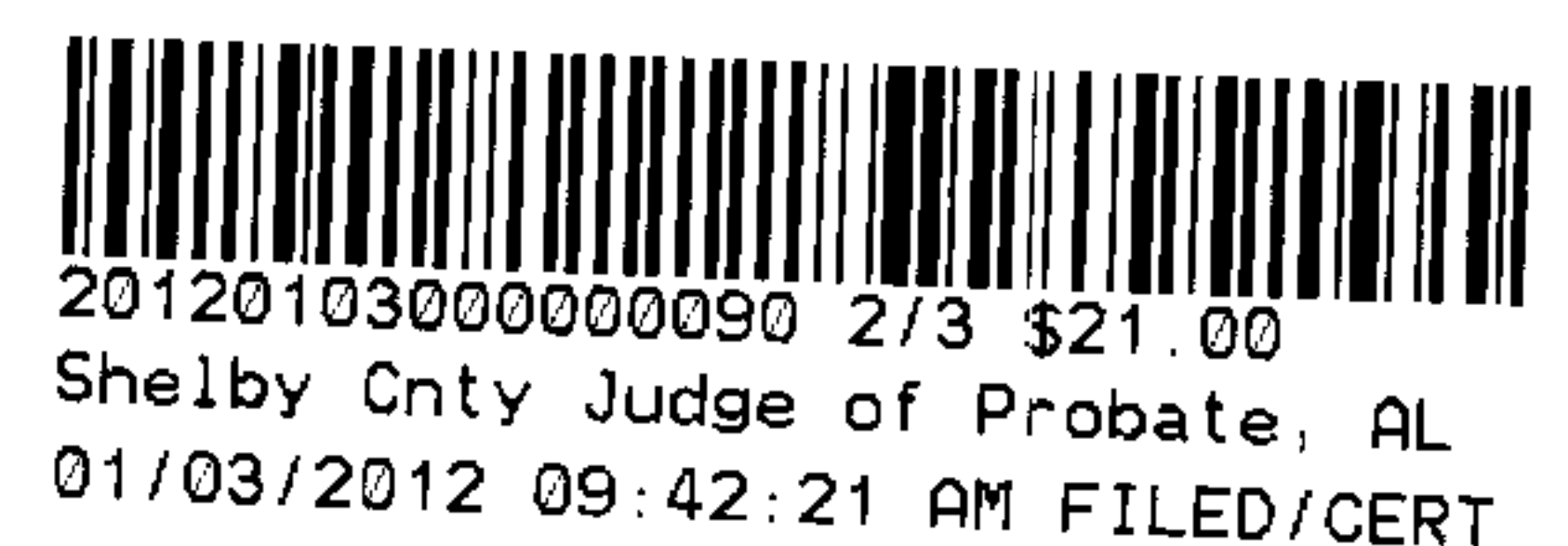
