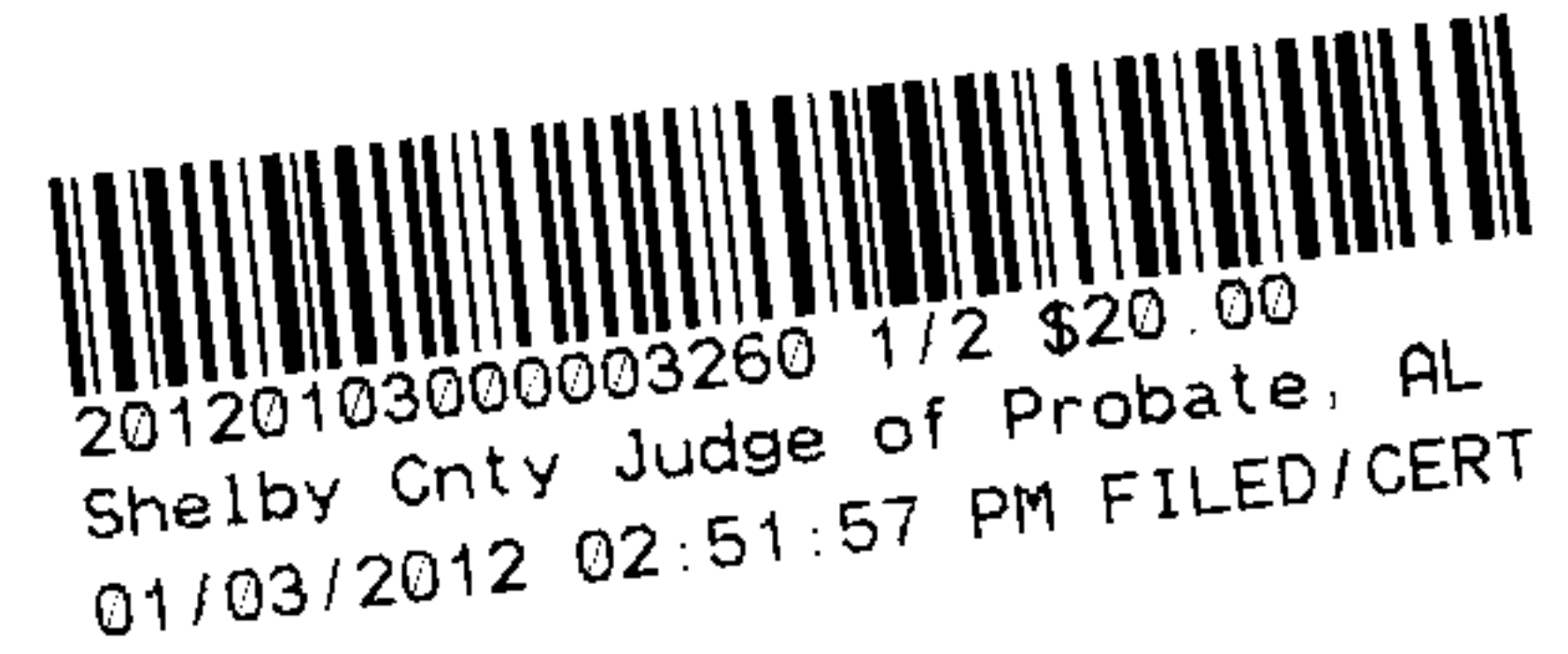

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on December 7, 2001, **Alice S Goggans and William K Goggans, a married couple, Party of the First Part**, executed a certain mortgage to **Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Homecomings Financial Network, Inc. its successors and assigns., party of the second part** which said mortgage is recorded in Instrument No. 2001-57125, in the Office of the Judge of Probate of Shelby County, Alabama Which said Mortgage was last sold, assigned and transferred to LNV Corporation in Instrument No.: 20080522000208880; and

WHEREAS, the highest and best bid obtained for the property described in the aforementioned mortgage was the bid of LNV Corporation in the amount of **NINETY-SIX THOUSAND AND 00/100 DOLLARS (\$96,000.00)**; and said property was thereupon sold to LNV Corporation; and
