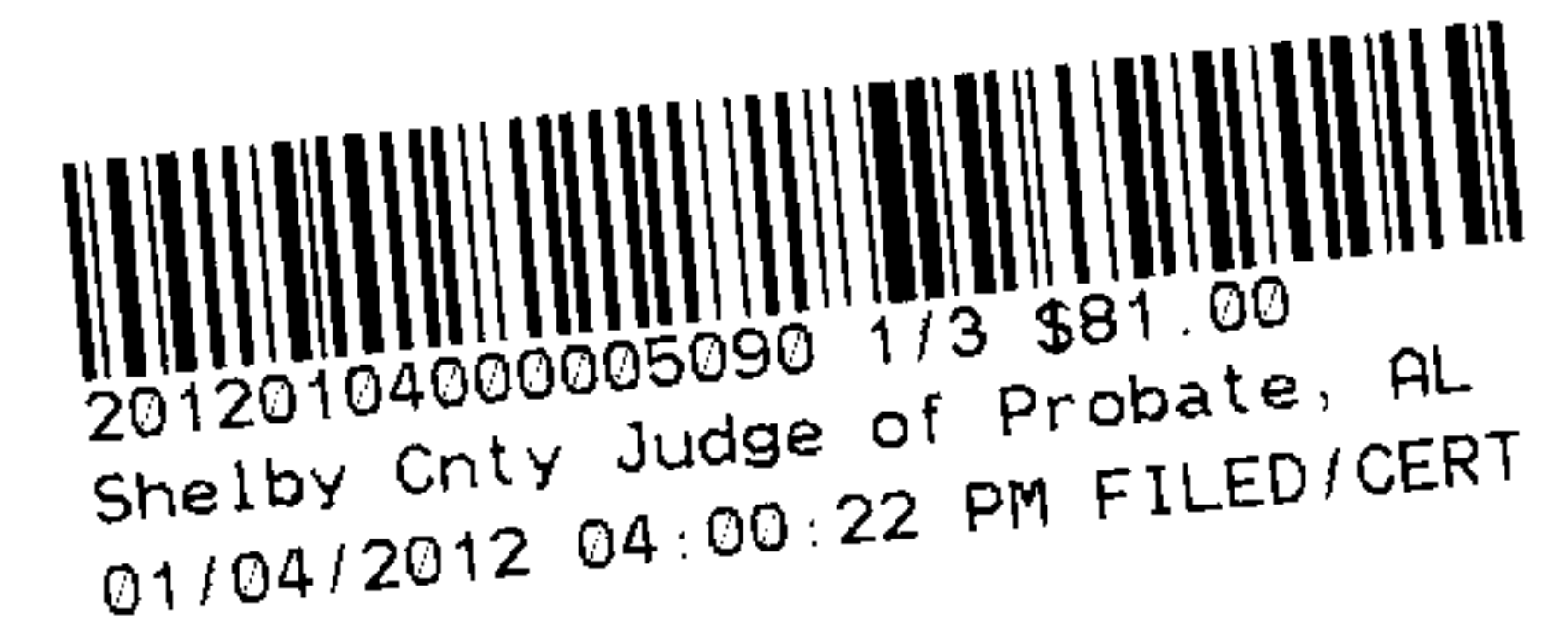

KNOW ALL MEN BY THESE PRESENTS,




(1) The name of the corporation is hereby amended and changed from Joseph Lumber Forest Enterprises, Inc. to Joseph Forest Enterprises, Inc.


(2) This Amendment was approved and adopted on December 31st, 2011.


