

ARTICLES OF ORGANIZATION  
OF  
FINANCIAL CONCEPTS & SOLUTIONS, L.L.C.

Pursuant to the Provisions of Sections 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I  
NAME

The name of the limited liability company is Financial Concepts & Solutions, L.L.C., (the "Company").

ARTICLE II  
DURATION

The Company shall have a duration from the date of organization until perpetuity, unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the "Act").

ARTICLE III  
PURPOSES

The purposes for which the Company is formed are:

(a) For any legal and lawful purpose pursuant to the Alabama Limited Liability Company Act, except for the purpose of banking or insurance;

(b) To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, accounting, financial, and other services of every nature, kind and character, which it may legally tender;

(c) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service, or other lawful business of any kind or character whatsoever;

(d) To act as agent, representative, or receiver of any person, firm,



corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;

(e) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;

(f) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof; and

(g) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested

#### ARTICLE IV REGISTERED OFFICE; REGISTERED AGENT

The location and street address of the initial registered office of the Company shall be 1055 Hermitage Circle, Birmingham, Alabama 35242, and its registered agent at such address shall be Rick Higgins.

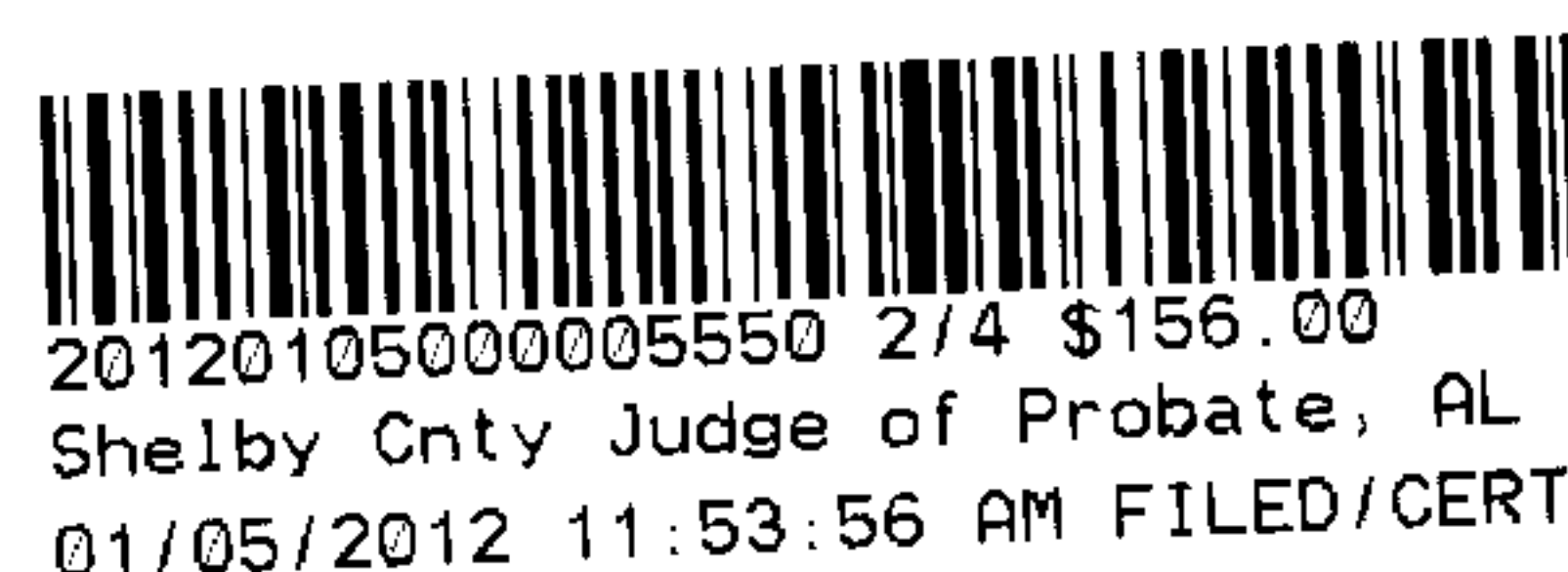

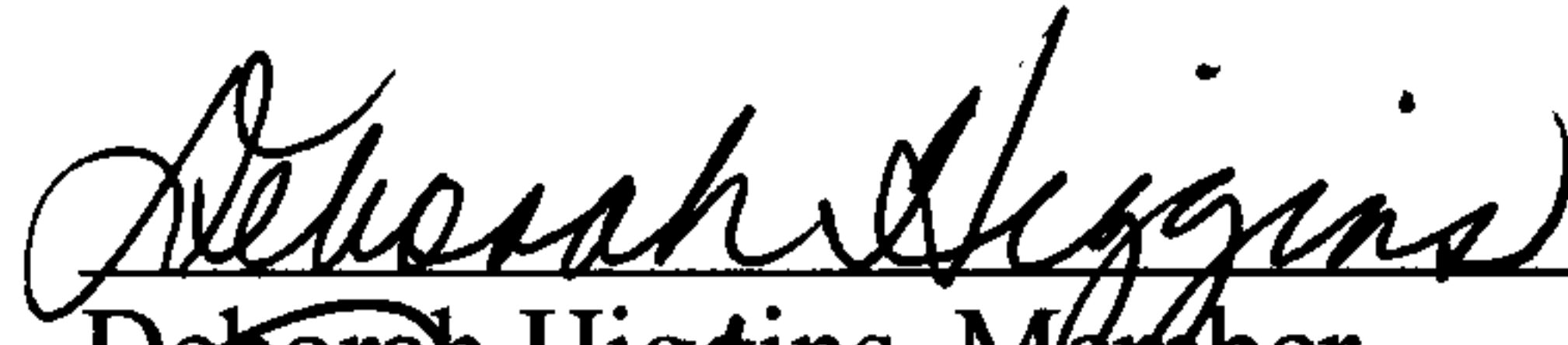
ARTICLE VI

The Company may be re constituted and the business of the Company may be continued following an event of dissociation which terminates the membership of a member of the Company if (i) there are at least two remaining members or at least one remaining member and a new member is admitted, and (ii) the business of the Company is continued by the written consent of all of the remaining members within 90 days after the occurrence of the event of dissociation.

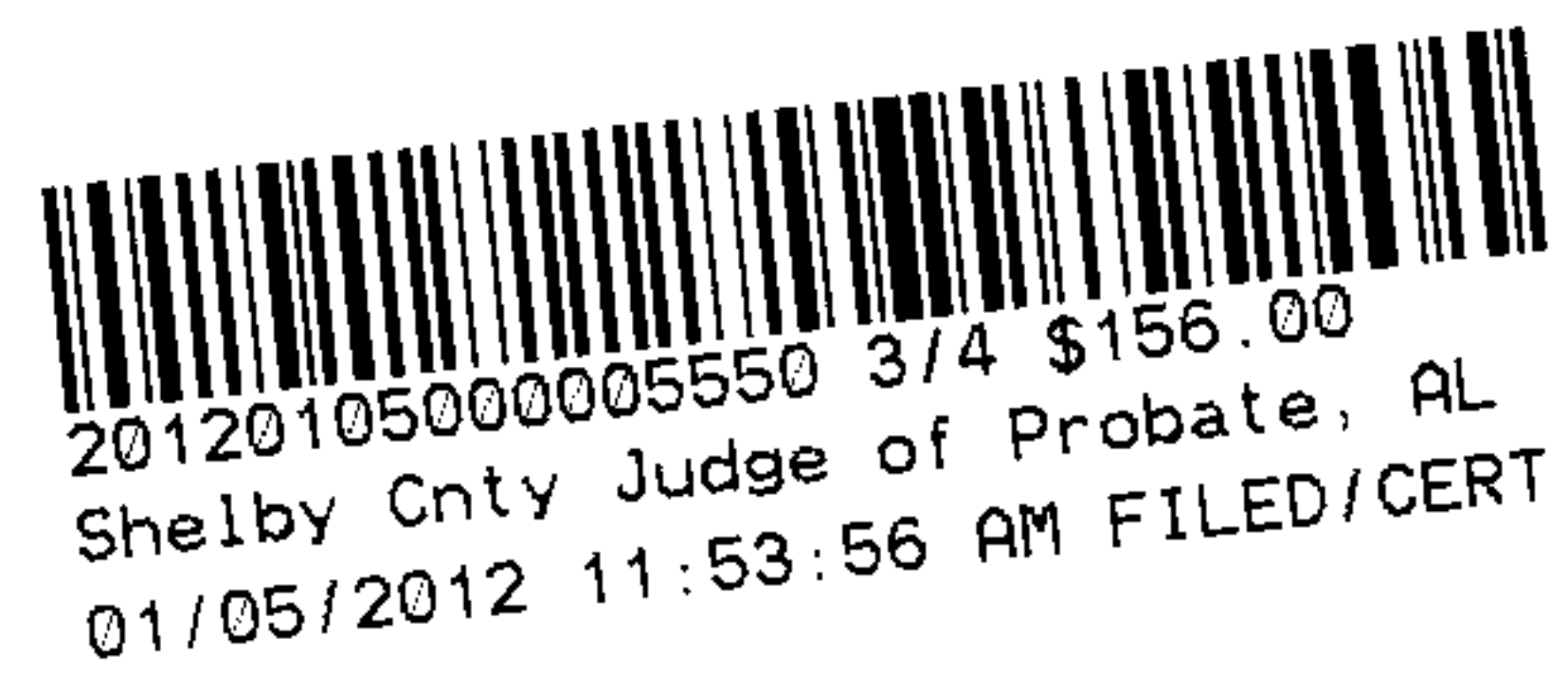
