CORRECTIVE QUITCLAIM DEED

COLLINS**, the receipt of which is acknowledged, I, **BILLY COLLINS**, a single man, hereinafter referred to as Grantor, remise, release, and quitclaim to **GWENDOLYN O COLLINS** all my right, title, interest, and claim in or to the following described property situated in the County of Shelby, State of Alabama:

THE SOUTHWEST QUARTER OF THE SOUTHWEST QUARTER (SW 1/4 OF SW 1/4) OF SECTION TWENTY NINE (29) ALL IN TOWNSHIP EIGHTEEN (18) SOUTH OF RANGE TWO (2) EAST, CONTAINING THIRTY FIVE POINT SIX (35.6) ACRES MORE OR LESS, AND THE WEST HALF OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER (NW1/4 OF SW1/4) OF SECTION 29, TOWNSHIP EIGHTEEN (18) RANGE 2 EAST CONTAINING FIFTY-FOUR ACRES MORE OR LESS, EXCEPT THE MINERAL AND MINING RIGHTS AND EXCEPT THE RIGHT OF WAY OF THE CENTRAL OOF GEORGIA RAILROAD ACROSS SAID OR ABOVE DESCRIBED LAND AND SUBJECT TO ANY EASEMENTS OF RECORD.
