SUBORDINATION AGREEMENT

This Subordination Agreement is made and entered into effective the <u>24th</u> day of <u>August</u>, <u>2011</u>, **BRYANT BANK** ("Secured Party") in favor of <u>Superior Bank</u>, N.A.

W-I-T-N-E-S-S-E-T-H:

WHEREAS, <u>Russell W Gentry and Karen S Gentry</u> (collectively, the "Borrowers") are the owners of certain real property and improvements located in <u>Shelby</u> County, Alabama, being more particularly described on <u>Exhibit A</u> attached hereto and incorporated herein by reference (the "collateral"); and

WHEREAS, the borrowers have previously obtained a loan from Secured Party in the original principal amount of \$150,000.00, which loan was secured by, among other things, a mortgage on the Collateral which was recorded 7/17/2008 in Mortgage Instrument 20080717000289300, in the Probate Office of Shelby County, Alabama (the "Mortgage"); and

WHEREAS, the Borrowers have obtained a loan from <u>Superior Bank N.A.</u>, as evidenced by that certain promissory note of even date herewith in the original principal amount of \$188,000.00; and

WHEREAS, Secured Party has agreed to subordinate its Mortgage and security interest in the Collateral to the mortgage and security interest to <u>Superior Bank N.A.</u>.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged and in the order to induce <u>Superior Bank N.A.</u> to make the said loan to Borrowers, it is hereby agreed as follows:

- 1) Secured Party hereby subordinated its Mortgage and security interest in the Collateral to the debt owed to <u>Bryant Bank</u> as described above and consents to and with <u>Superior Bank N.A.</u> and Mortgagor that the Mortgage and the security interest of Secured Party in and to the Collateral, is now, and shall continue to be subject and subordinate to the mortgage and security interest granted by Mortgagor to <u>Superior Bank N.A.</u> in an amount up to \$188,000.00, together with all advances made thereon and all fees, expenses, and cost, including attorney's fees, uncured in connection with said loan.
- 2) That this Agreement shall be binding upon and secure the parties hereto and their respective successors and assigns and shall inure the benefit of <u>Superior Bank N.A.</u>, its successors and assigns.

3) That this agreement shall continue to apply, without restriction or limitation, to any modifications, amendments, additions or deletions to the indebtedness of Borrowers to Bryant Bank which is secured by the Collateral; provided, however, that this Agreement shall not apply to the extent of any indebtedness from Borrowers to Bryant Bank in excess of \$150,000.00 together with all advances made thereon and all fees, expenses, and costs, including attorney's fees, incurred in connection with said loan.
