THIS AGREEMENT is made and entered into on this 2 day of **December, 2011**, by Regions Bank (Hereinafter referred to as "Regions") in favor of **WELLS FARGO BANK, N. A.**, its successors and assigns (hereinafter referred to as "Lender").

RECITALS

Regions loaned to **Joy L Stringfellow and Larry Thrasher** (the "Borrower", whether one or more) the sum of \$ **\$18,000.00**. By its acceptance of this agreement, the borrower agrees to pay the subordination Fee set out in the Regions Subordination Request Form.
