KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of January, 2008, Lois Bakane, unmarried , executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., solely as nominee for AFS Financial, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080114000017890, said mortgage having subsequently been transferred and assigned to Bank Of America, N.A. successor by merger to BAC Home Loans Servicing, LP fka Countrywide Home Loans Servicing, LP, by instrument recorded in Instrument Number 20110916000275320, in the aforesaid Probate Office ("Transferee"); and
