} KNOW ALL MEN BY THESE PRESENTS,

SHELBY COUNTY

That in consideration of Sixty Five Thousand dollars and Zero cents (\$65,000.00) to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, Milton L. Smith, a single man (herein referred to as grantors) do grant, bargain, sell and convey unto Michael D. Frederick and Kelley R. Frederick (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Subject to taxes for 2012 and subsequent years, easements, restrictions, rights of way, and permits of record.


