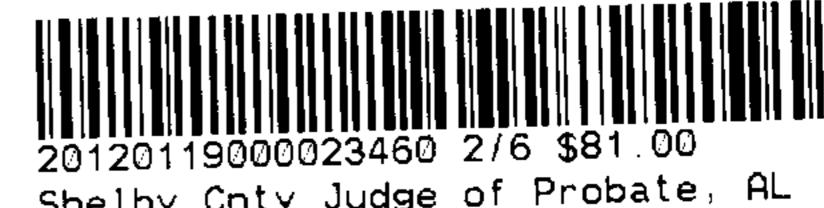
ARTICLE VII
