KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 4th day of August, 2006, Richard L. Page, a single man, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for America's Wholesale Lender, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20060811000391450, said mortgage having subsequently been transferred and assigned to The Bank of New York Mellon FKA The Bank of New York, as Trustee for The Certificate Holders CWALT, Inc., Alternative Loan Trust 2006-28CB Mortgage Pass-Through Certificates, Series 2006-28CB, by instrument recorded in Instrument Number 20091008000382070, in the aforesaid Probate Office ("Transferee"); and

published in Shelby County, Alabama, in its issues of November 9, 2011, November 16, 2011, and November 23, 2011; and

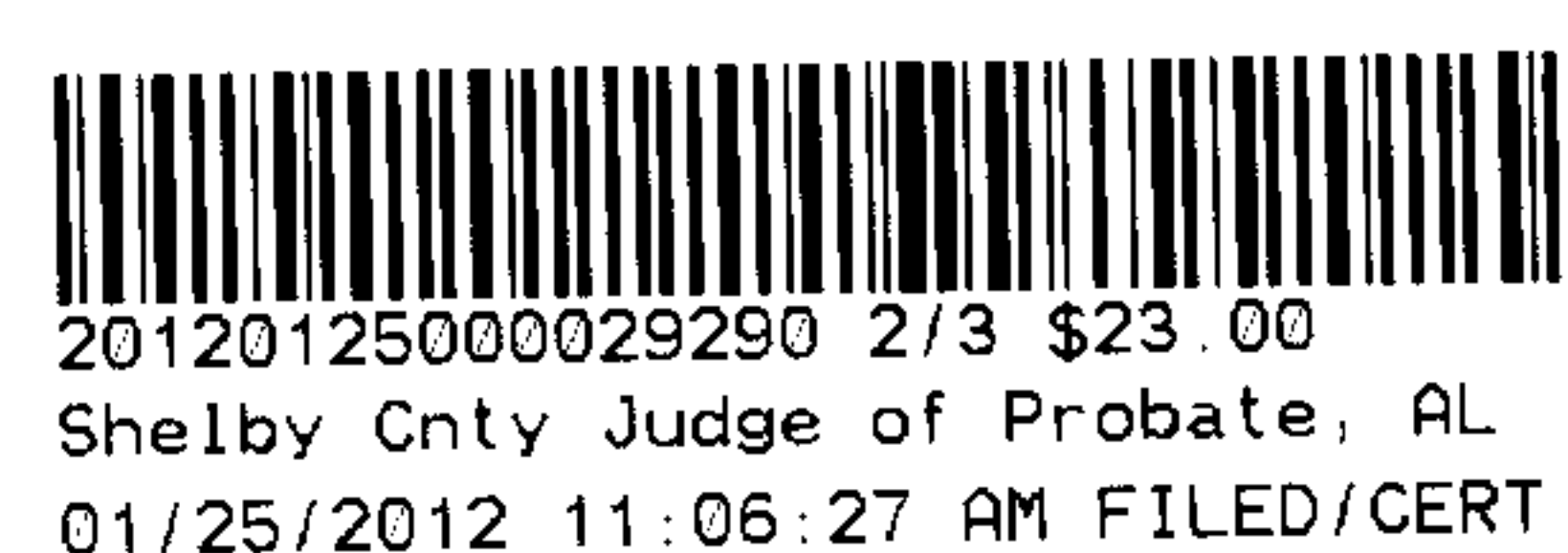
