


WARRANTY DEED
Joint Tenants with Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, That in consideration of **Two Hundred, Thirty Two Thousand and no/100's Dollars (\$232,000.00)** and other good and valuable consideration to the undersigned grantor,

AFK LAND, LLC, an Alabama limited liability company

(hereinafter referred to a GRANTOR) in hand paid by the GRANTEES the receipt whereof is hereby acknowledged the said GRANTOR does by these presents, grant, bargain, sell and convey unto

ROBERT A. RICKMAN and HEATHER N. RICKMAN

(hereinafter referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 412, according to the Survey of Lake Forest, Fourth Sector, as recorded in Map Book 28, Page 93, in the Probate Office of Shelby County, Alabama.

This conveyance subject to:

- 1. One year statutory right of redemption in favor of all persons entitled to redeem the above-described property from that certain mortgage foreclosure deed dated April 29, 2011, recorded in Instrument No. 20110429000130090;**
- 2. Taxes for the year 2012 and subsequent year;**
- 3. Easements, exceptions, reservations, encumbrances, liens, rights of way and restrictions not of record or visible on said property;**
- 4. Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including release of damages, are not insured herein;**
- 5. Right of way granted to Alabama Power Company recorded in Volume 239, Page 881; Volume 219, page 127, Volume 150, Page 89 and Volume 124, Page 474;**
- 6. Restrictions and Covenants appearing of record in Instrument 2001-27183 in the Office of the Judge of Probate of Shelby County, Alabama.**

\$208,800.00 of the above consideration is paid by a Purchase Money Mortgage filed simultaneously herewith.

TO HAVE AND TO HOLD, unto the said GRANTEES, as joint tenants, with right of survivorship, their heirs and assigns forever, it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the GRANTEES herein) in the event that one GRANTEE herein survives the other, the entire interest in fee simple shall pass to the surviving GRANTEE, and if one does not survive the other, then the heirs and assigns of the GRANTEES herein shall take as tenants in common. And said GRANTOR does for itself, its successors and assigns, covenant with said GRANTEES, their heirs and assigns, that it is lawfully seized in fee simple of said premises, that they are free of all encumbrances, unless otherwise noted above; that it has a good right to sell and convey the same as aforesaid; that it will and its successors and assigns shall warrant and defend the same to the said GRANTEES, their heirs and assigns forever, against the lawful claims of all persons.


