The name of the owner of the said property is Hubert and Leonetta Prevo.

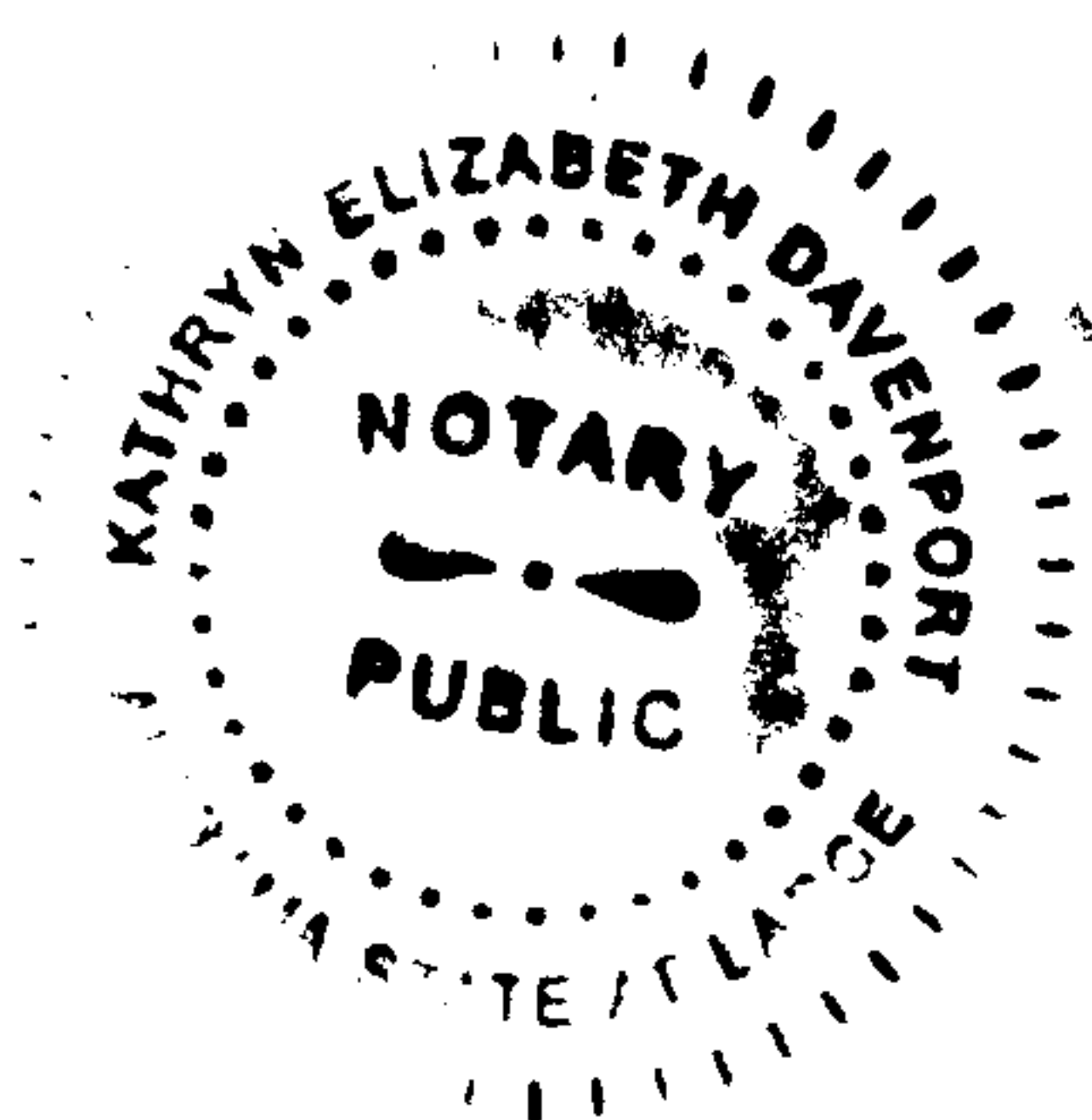
