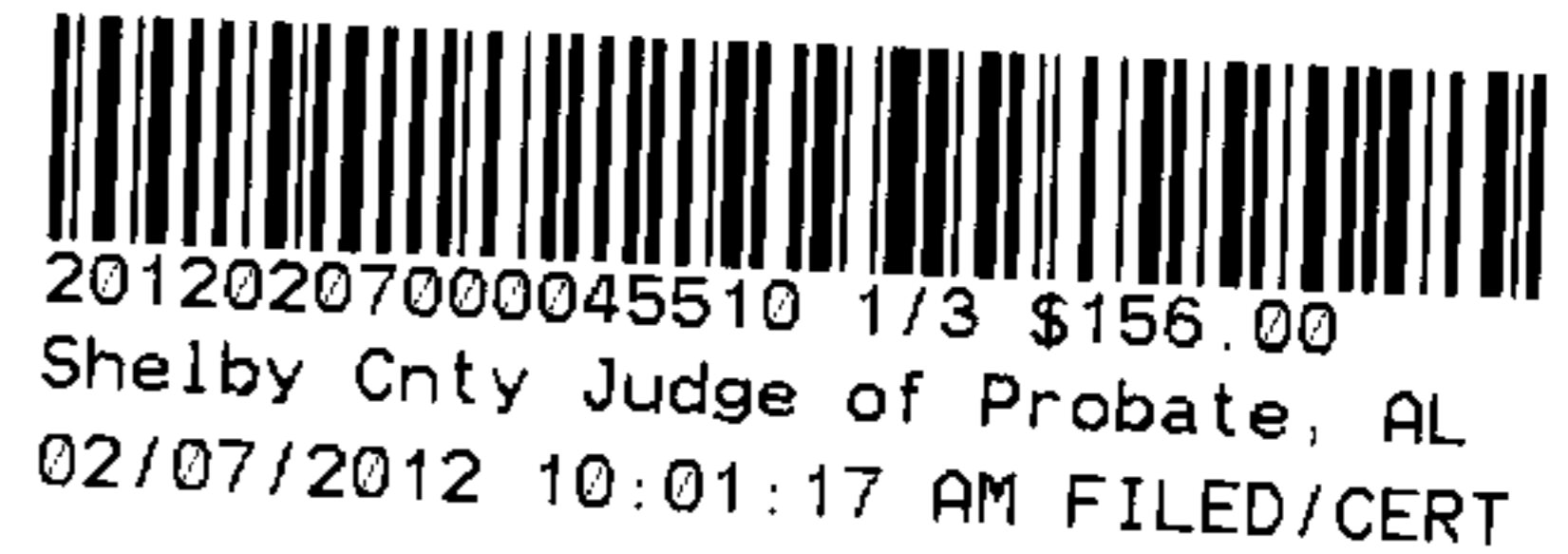


ARTICLES OF ORGANIZATION
OF
YESSICK PROPERTIES, LLC



The undersigned, for the purpose of forming and establishing a limited liability company under the laws of the State of Alabama and pursuant to the provisions of the Alabama Limited Liability Company Act, Code of Alabama 1975, §§ 10-12-1 through 10-12-61 (the "Act") and all amendments thereto, certify as follows:

1. The name of the limited liability company (the "Company") is: Yessick Properties, LLC.

2. The existence of the Company shall begin on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall be perpetual, unless the Company shall be earlier dissolved in accordance with the provisions of the Company's operating agreement, or, if there is no provision in an operating agreement of the Company governing dissolution of the Company, then in accordance with the provisions of the Act.

3. The primary purpose for which the Company is organized is the acquisition, leasing and management of residential rental properties in Shelby County, Alabama and in Jefferson County, Alabama and all activities incidental or related thereto. The Company may transact any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Act.

4. The location and mailing address of the initial registered office of the Company shall be 1001 Briarcliff Trace, Birmingham, Alabama 35242, and the name of the initial registered agent at such address shall be Donald L. Yessick.

5. The name and mailing address of the initial member of the Company is Donald L. Yessick, 1001 Briarcliff Trace, Birmingham, Alabama 35242.


6. Additional members may be admitted in accordance with the terms of the Company's operating agreement, if any. If there is no provision in an operating agreement of the Company governing the admission of additional members, additional members may be admitted with the written consent of all members at such times and upon such terms and conditions as may be mutually agreed upon by the members and the person desiring to become a member.


7. The cessation of membership of one or more members will not result in the dissolution of the Company.

8. The Company shall be managed by its manager. Except for situations in which the approval of the members is expressly required by the Company's operating agreement or nonwaivable provisions of the Act, the manager shall have full and complete authority, power and discretion to manage, control and make all decisions regarding the business, affairs

(including the formulation of policies and management of financial affairs) and properties of the Company, and to perform any and all other acts or activities customary or incident to the management of the Company's business. The name and mailing address of the initial manager of the Company is Donald L. Yessick, 1001 Briarcliff Trace, Birmingham, Alabama 35242.
