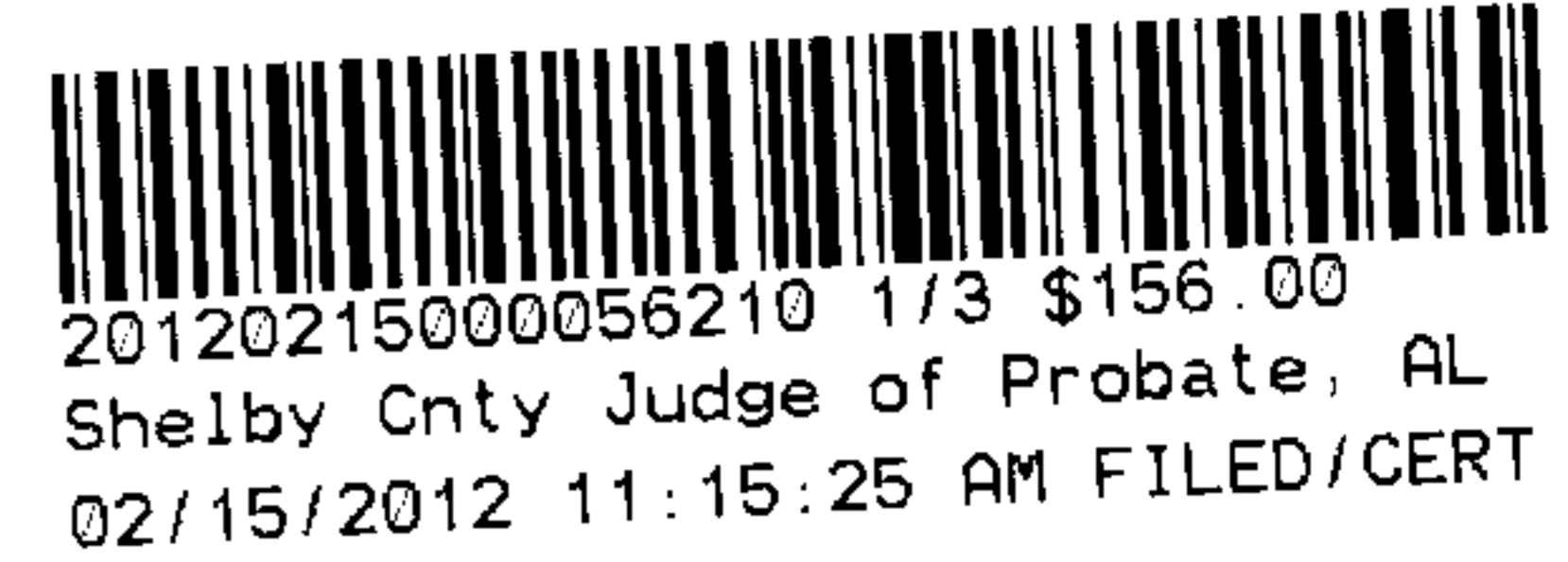


ARTICLES OF INCORPORATION FOR E-CITY DEVELOPMENT, INC,  
AN ALABAMA CORPORATION

**ARTICLE I**

The name of this corporation is E-City Development Inc.



**Article II**

The corporation is of perpetual duration.

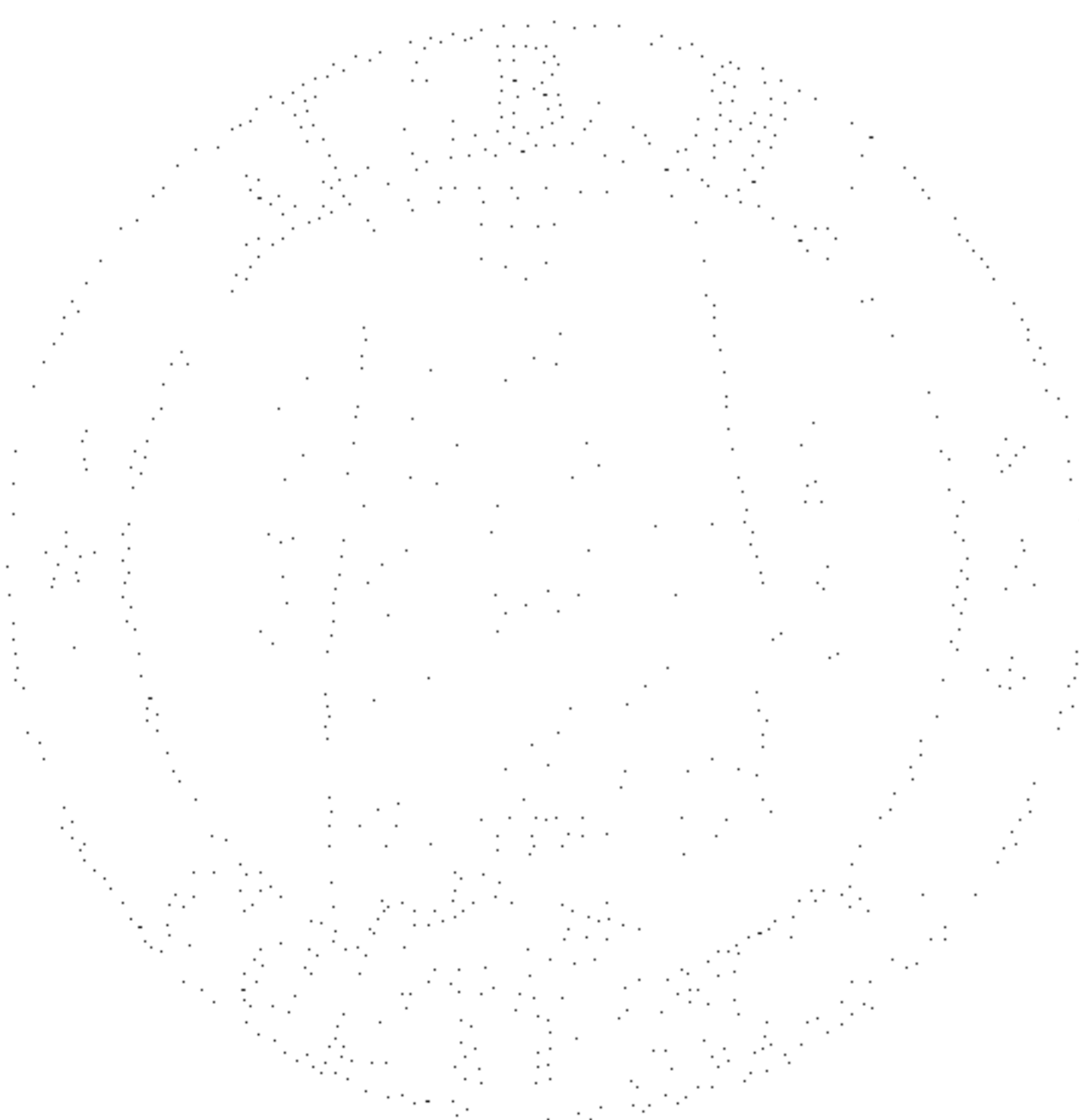
