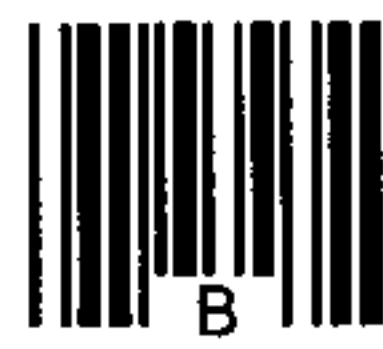
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 7th day of November, 2008, Catherine Greever, a married woman, and her spouse, James Hutton Greever, Jr., executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for MortgageAmerica, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20081125000450100, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA, by instrument recorded in Instrument Number 20101214000419960, in the aforesaid Probate Office ("Transferee"); and
