

ARTICLES OF INCORPORATION
OF
ADVANTAGE WINDOW FILMS OF ALABAMA, INC.

The undersigned, in order to form a business corporation for the purposes hereinafter stated, under and pursuant to the provisions of the *Alabama Business and Nonprofit Entity Code*, hereby adopts these Articles of Incorporation (sometimes referred to "Certificate of Formation") and certifies that:

1. The name of the corporation (hereinafter referred to as the "Corporation") is ***Advantage Window Films of Alabama, Inc.***

2. The purpose for which the Corporation is organized is to engage in any lawful act or activity for which corporations may be organized under the *Alabama Business and Nonprofit Entity Code*, including, but not limited to providing home maintenance and general construction services.

3. The duration of the Corporation shall be perpetual.

4. The initial registered agent of the Corporation is Anthony W. Riggins and the initial registered office of the Corporation is located at 105 Reese Drive Alabaster, Alabama 35007.

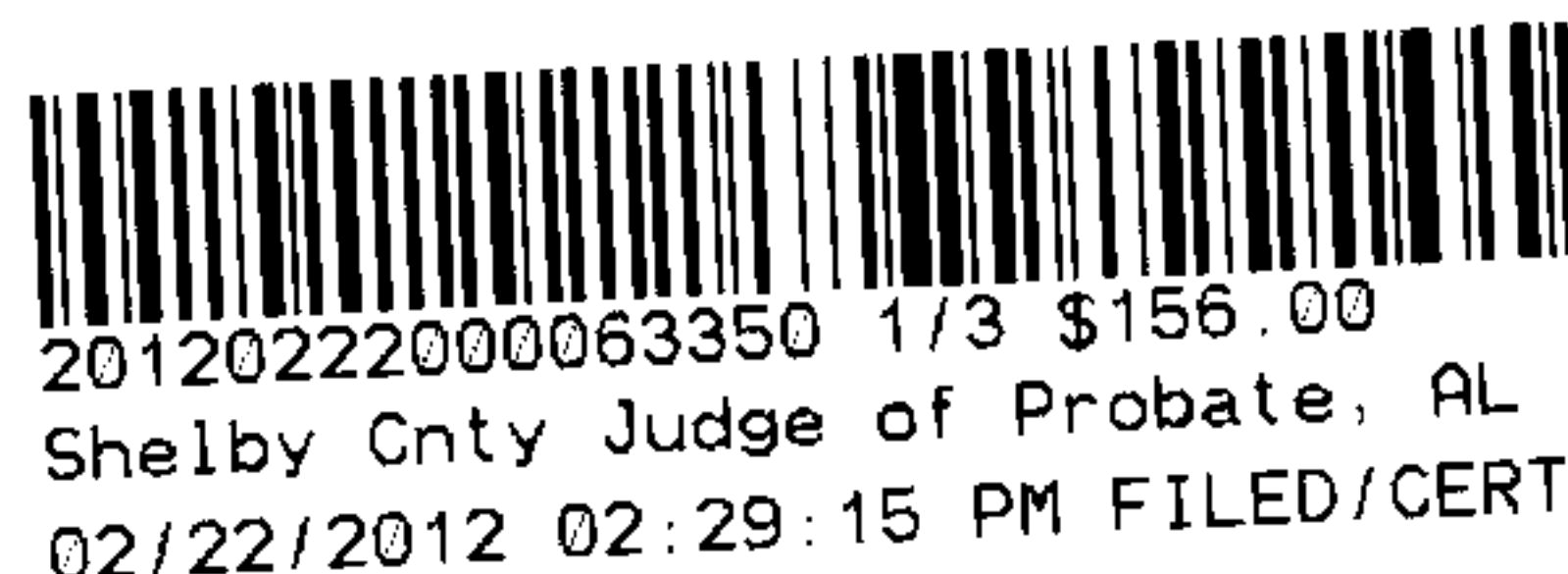
5. The name and address of the incorporator of the Corporation is Anthony W. Riggins, 105 Reese Drive Alabaster, Alabama 35007.

6. There shall be one class of stock, and the Corporation is authorized to issue One Thousand (1,000) shares of common stock.



8. The Board of Directors of the Corporation, acting by majority vote, may adopt, alter, amend, or repeal the By-Laws of the Corporation.

Except as otherwise provided by the *Alabama Business and Nonprofit Entity Code* as the same exists or may hereafter be amended, no director of the Corporation shall be personally liable to the Corporation for monetary damages for any action taken or any failure to take any action. Any repeal or modification of this provision by the Corporation shall not adversely affect any right or protection of a director of the Corporation existing at the time of such repeal or modification.

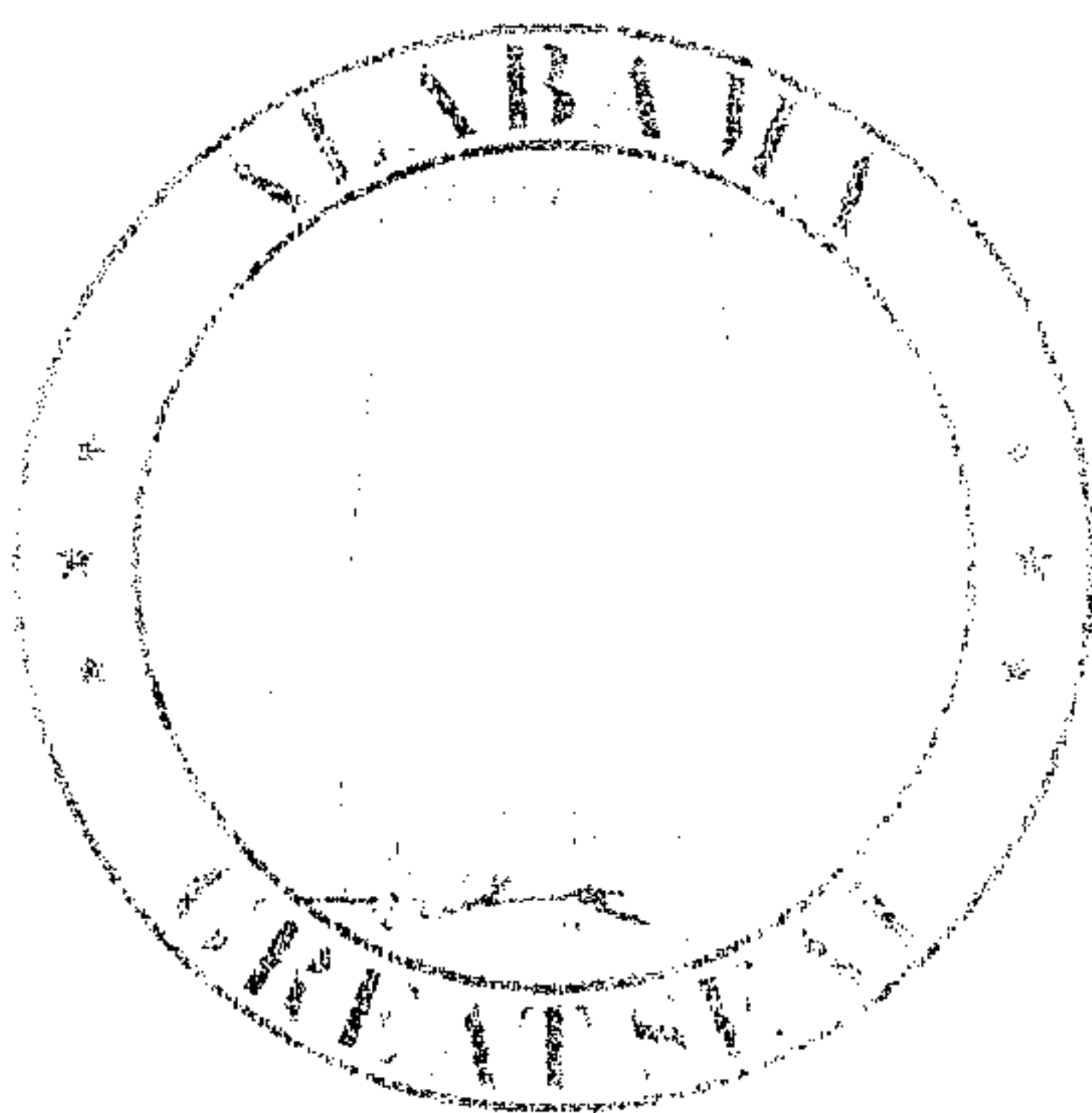
