## EXHIBIT A

Commence at an ½" iron in place being the Southwest corner of the Southwest one-fourth of the Northeast one-fourth of Section 3, Township 20 South, Range 1 West, Shelby County, Alabama, said point being the point of beginning. From this beginning point proceed North 58° 47' 03" East for a distance of 1389.82 feet (set 1/2" rebar); thence proceed South 10° 10' East for a distance of 687.94 feet to a point on the South boundary of said quarter-quarter section (set 1/2" rebar); thence proceed South 88° 06' 48" West along the South boundary of said quarter-quarter section for a distance of 1310.75 feet to the point of beginning.
