

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That:

WHEREAS, heretofore on March 14, 2008, Michael Houser, unmarried man and Brittany Freeman, unmarried, Party of the First Part, executed a certain mortgage to SunTrust Mortgage, Inc., party of the second part which said mortgage is recorded in Instrument No. 20080425000168670, in the Office of the Judge of Probate of Shelby County, Alabama.
