

**ARTICLES OF ORGANIZATION
OF
COLE-TYSON LAND & GARDEN DESIGN LLC**

Pursuant to Ala. Code §10A-1-3.05 and §10A-5-2.02 (1975) of the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Limited Liability Company ("LLC") Articles of Organization:

**ARTICLE I
NAME**

The name of the LLC is Cole-Tyson Land & Garden Design LLC d/b/a ACT Land & Garden Design & Consulting.

**ARTICLE II
DURATION**

The period of duration is perpetual.

**ARTICLE III
PURPOSES**

- A) To own and operate a land and garden design and consulting business and to conduct all related activities to the same extent the same may be legally exercised by limited liability companies under the Alabama Limited Liability Company Act; and
- B) To engage in any and all lawful purposes for which limited liability companies can and are organized under the laws of the State of Alabama consistent with paragraph (A) above.

**ARTICLE IV

ADDITIONAL MEMBERS

Additional Members may be admitted upon obtaining the written consent of a majority in interest of the remaining members; the payment or provision of a capital contribution and execution of an admission agreement.

ARTICLE VII
MANAGEMENT

Management is vested in the Members of the Company.

ARTICLE VIII
OPERATING AGREEMENT

The Operating Agreement of the LLC shall be executed by each Member of the LLC and shall set forth all provisions for the regulation of the internal affairs of the LLC and the conduct of its business to the extent that such provisions are not inconsistent with the laws of Alabama or these Articles. The Operating Agreement shall include, without limitation, provisions regarding members, company capital, allocations, distributions, management of the company, transfer of interest, dissolution, accounting records, the tax matters, members and indemnification. Those provisions together with any other provisions included in the Operating Agreement are hereby incorporated by reference.

ARTICLE IX
CESSATION AND DISSOLUTION

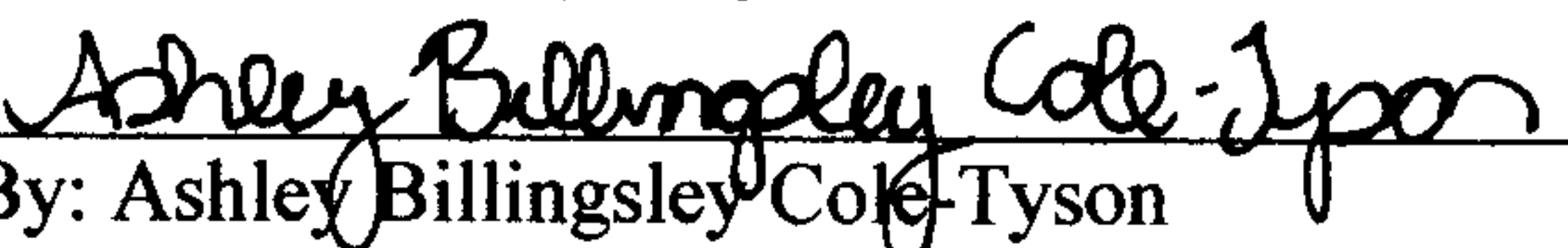
The cessation of membership of one or more members will not result in dissolution of the LLC.
