

ARTICLES OF ORGANIZATION

of

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is Bill Brasher & Associates, LLC.

2. The existence of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue until it is dissolved as provided in the Operating Agreement, or if no provision in the Operating Agreement governs the duration of the Limited Liability Company, as may be required by the Alabama Limited Liability Company Law.

3. The purposes for which this Limited Liability Company is organized are: (a) to acquire, own, purchase, develop, invest in, deal in, lease and sublease real property of every kind; (b) to borrow money and issue notes and other evidence of indebtedness; and (c) to engage in the transaction of any or all other lawful business for which Limited Liability Companies may be organized under the laws of the State of Alabama.

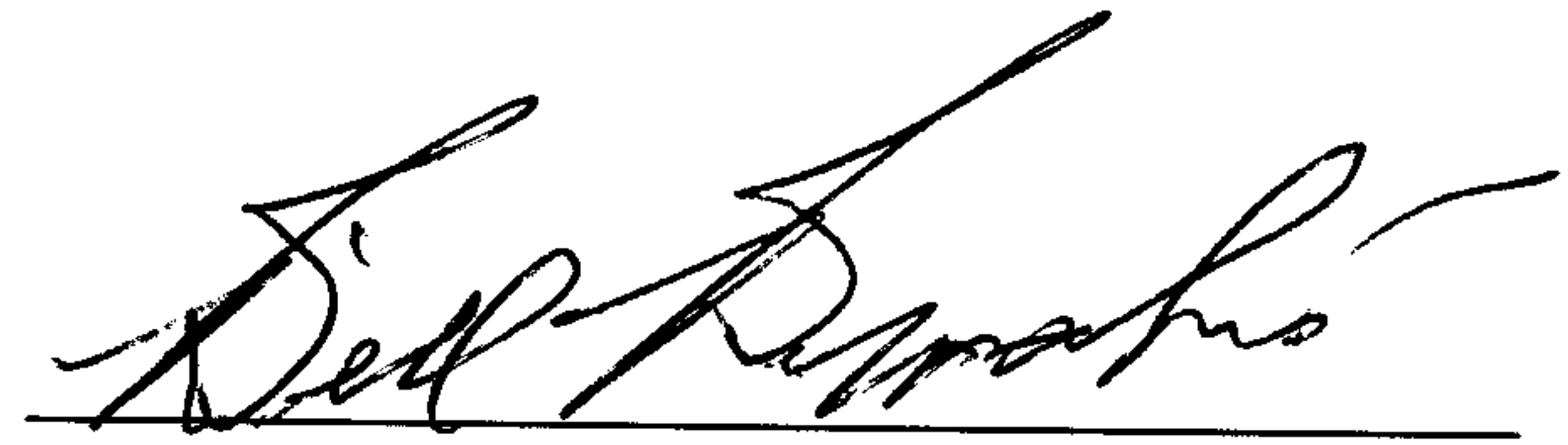
