

That in consideration of TEN DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

## JOYCE TAYLOR LEVI aka JOYCE T. LEVI, AN UNMARRIED WOMAN

(herein referred to as Grantor, whether one or more), grants, bargains, sells, and conveys unto

## JOYCE T. LEVI AND JOANNE L. MATHISON, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE LEVI LIVING TRUST, DATED MARCH 19, 2012 AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

The North ½ of the SE ¼ of the NW ¼ of Section 6, Township 24, Range 14 East, Shelby County, Alabama, lying West of Wally Watson Road. Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

Irving L. Levi, III aka Irving Lafayette Levi, III is the grantee of the above described property as shown in that certain warranty deed recorded at Instrument Number 2000-12603 in the Probate Court of Shelby County, AL. Irving Lafayette Levi, III died on or about April 24, 2010. A copy of his death certificate is attached. His Last Will and Testament was filed for probate in the Probate County of Jefferson County, AL (Birmingham, Division). On June 11, 2010, the Estate of Irving Lafayette Levi, III, having a case number 208604 was opened. Under the terms of the will, the above described property was devised to Joyce Taylor Levi, the above named Grantor. The Decree on Final Settlement showing Joyce Taylor Levi as the sole beneficiary was executed by the probate judge on January 31, 2012.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said **GRANTEE**, his, her or their successors and assigns, that I am (we are) lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I (we) have a good right to sell and convey the same as aforesaid; that I (we) will and my (our) heirs, executors and administrators shall warrant and defend the same to the said **GRANTEE**, his, her or their successors and assigns forever, against the lawful claims of all persons.
