AFFIDAVIT OF HEIRSHIP BY DISINTERESTED PARTY

Before me, the undersigned, a Notary Public in and for said County in said State, personally appeared Mark McLaughlin who, being by me, first duly sworn, deposes and states as follows:

1. That I am over the age of twenty-one years, and that I have personal knowledge of the information herein.

7. As of this date, the heirs at law of G.H. Grimes and Lillian Grimes are as follows:

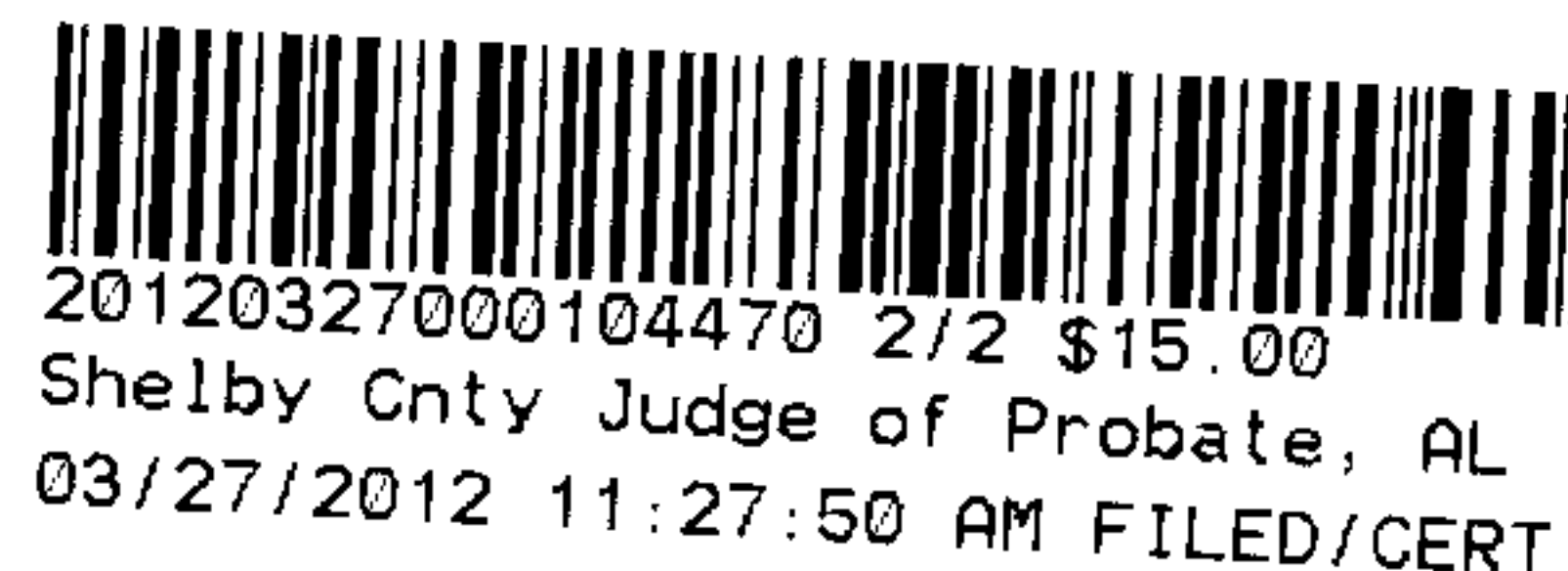
