## SPECIAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS,

## SHELBY COUNTY

That in consideration of Eighty-seven thousand and 00/100 Dollars (\$87,000.00) to the undersigned, Fannie Mae aka Federal National Mortgage Association, a corporation, by and through Sirote & Permutt, P.C., as Attorney in Fact, (herein referred to as Grantor) in hand paid by the Grantee herein, the receipt whereof is acknowledged, the said Grantor does by these presents, grant, bargain, sell and convey unto Rebecca Guthrie, (herein referred to as Grantee), the following described real estate situated in Shelby County, Alabama, to-wit:

These restrictions shall run with the land and are not personal to grantee.





This restriction shall terminate immediately upon conveyance at any foreclosure sale related to a mortgage or deed of trust.
