WHEREAS, Johnilea L. Gillespie ("Johnilea") died on May 19, 2011 and her Last Will and Testament ("Will") was admitted to probate in Shelby County Probate Court Case Number PR-2011-000419;

WHEREAS, Jack I. Gillespie ("Jack") was appointed as Personal Representative of Johnilea's estate by Letters Testamentary issued July 25, 2011;

WHEREAS, Jack is named as Trustee of the Family Trust ("Family Trust") created under Johnilea's Will;

WHEREAS, Johnilea died seized and possessed of the real property hereinafter described (the "Property");
