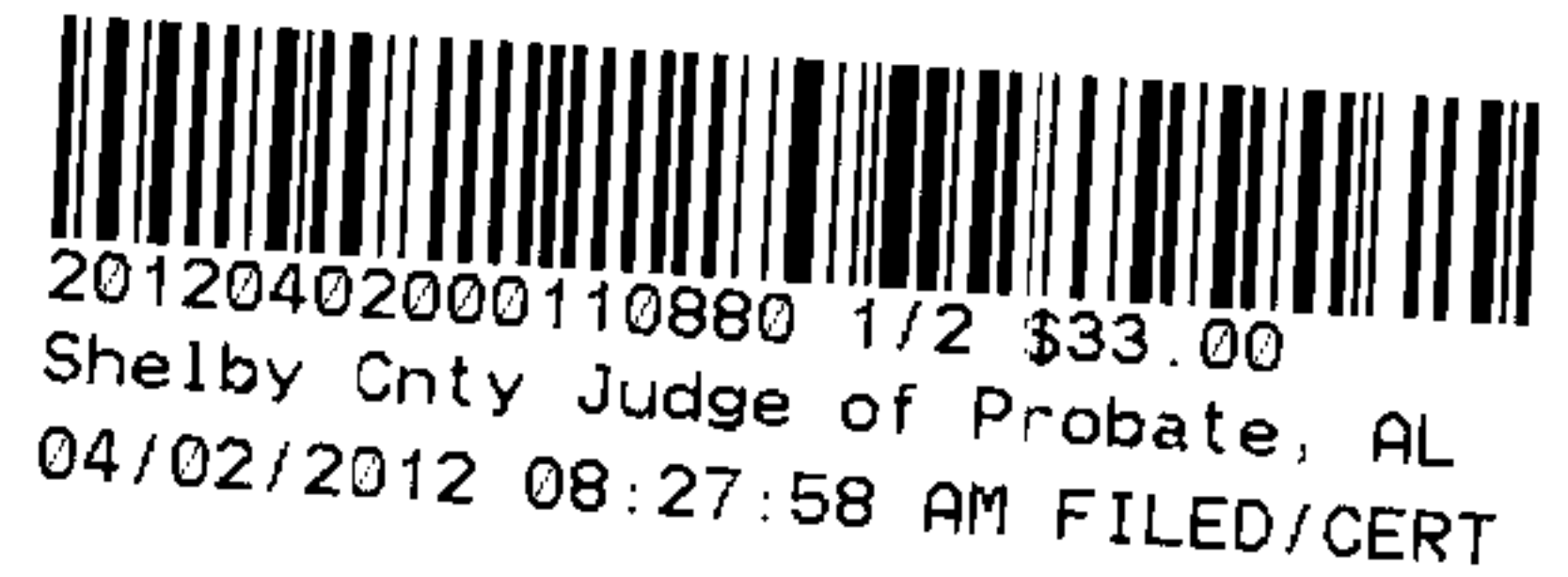


## NOTARY BOND

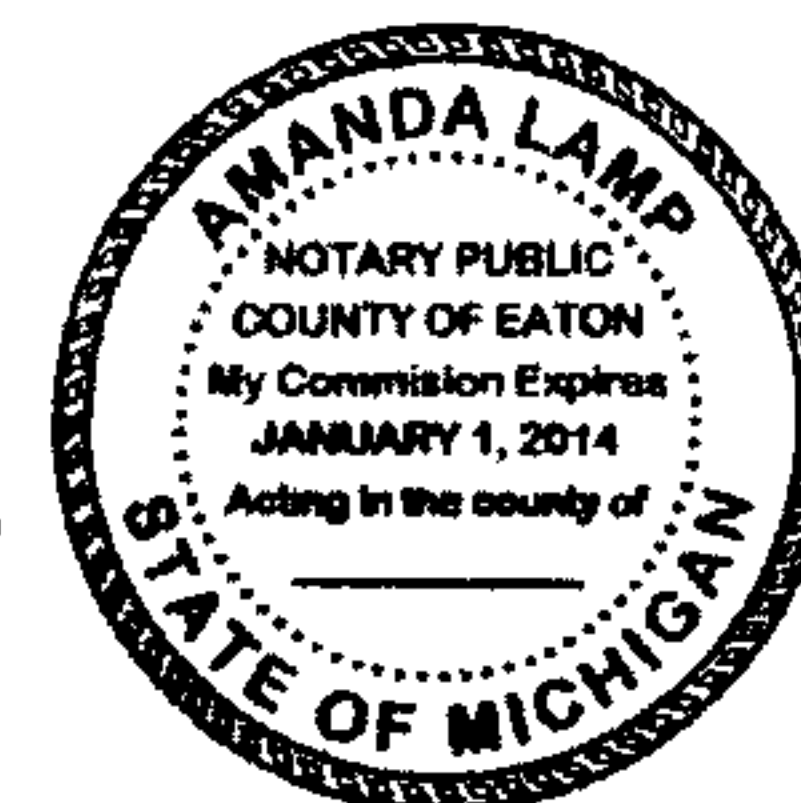


